Respected Sir,

I, **Tuktuki Khatun**, Wife of Sk. Imdadula Faruque, Resident of Ashraf Nagar, Buddha Mandir Road, Gital Para, Ward No. 40 of SMC, P.S. Bhaktinagar, Dist:- Jalpaiguri, begs to state as follows:-

1. That my Grand Mother namely Late. Dolana Khatun, wife of Late. Azizul Haque purchased a land measuring 5 kathas in the year 1987.
2. That during her lifetime she gifted a land measuring 1 Kathas and 11 Chhatak to her elder son i.e. my father namely Late. Mohammad Samsul Haque, Son of Azizul Haque in the year 2000 and after giving the said land as gift to my father my grandmother expired on 15/08/2003 leaving behind her 5 legal heirs namely a) Mohammad Samsul Haque (Son), b) Manu Haque (Son), c) Khokhon Haque (Son), d) Gulnihar Bibi (Daughter), e) Aruna Shekh (Daughter).
3. That after the death of my grandmother my Paternal Uncles namely a) Manu Haque and b) Khokhon Haque transferred the remaining land illegally without having any legal right in the name of their wives a) Adina Begum @ Argina Begum and b) Chhabi Begam, by way of Gift suppressing the fact that they had/have 2 more sisters and that they were only 3 legal heirs including them and did not disclose about the sisters who were also the legal heirs and having equal inheritance right over the remaining land left by my grandmother and the said 2 uncles also did not give any share to my father and illegally transferred the said land among their wives.
4. That later on in the year 2011 my paternal aunt namely Gulnihar Bibi transferred her share of land i.e. 8 Chhatak in my name by the way of Gift Deed.

5. That there after I approach the Ld. Civil Judge Senior Division at Jalpaiguri, and the Ld. Court was pleased to pass the "Order No.1, dated 18.04.2026 The plaintiff and defendants are hereby directed to maintain status quo in respect of nature and character as well as possession of the suit land and the defendants are hereby restrained to alienate or to create any third party interest in respect of suit land till the next date of hearing".

6. That even after receiving an order from the Ld. Civil Judge Senior Division at Jalpaiguri accused namely Manu Haque along with his wife Adina Mon Hague Begam, daughter Jhumpa Khatun and son namely Moni Haque have been removing the bamboo which was being used for the shuttering purpose and are trying to change the nature of the said disputed property.

I therefore request you to kindly take necessary legal acting against the aforesaid culprits for the ends of justice.
