The incident occurred between 9 PM last night and 5 AM this morning. When the priest arrived this morning, we discovered that the locks of the Almiraha were broken. And theft are coming back side of priest home broken the roof & Door.

The following items were stolen:

2. Cash & Valuable Items from the Almiraha (estimated amount: ₹\_30,000.00)

The thieves have broken the Almiraha, locker, window, Roof, Door and vandalized the sanctum sanctorum, severely hurting the religious sentiments of the local community.
