Respected Sir,

I, Md. Mansur Alam, S/o- Late. Md. Nasiruddin, R/o- Natun Para, Near Ram Ghat, Jalpai More, Siliguri, Dist.- Darjeeling, would like to draw your kind attention to the following effect that today i.e., 12/05/2026 at around I received a phone call from 7319460131 at 17:03 hrs, which is the number of SI Kalachand Mondal who called me for the purpose of enquiry/investigation in connection with the case Siliguri P.S. Case No- 209/2026. He told me that I have to accompany them at my actual residence for the purpose of investigation, which is situated at Natun Para, Near Ram Ghat, which is presently forcibly occupied by my wife and my in-laws. Initially I insist to visit the place as because of my wife and her parents aggressive nature but at the end as per the direction of the police personnel I visited the place at around 19:40 hrs with the police personnel i.e., Kalachand Mondal and another police personnel and during the enquiry I was at the ground floor with the police officers at above mentioned place, but soon initiate the enquiry the police personnel goes another side of the place to enquire about the matter or getting information from the neighbours of the area at that time my mother in law Dilara Begum enter the place from outside and assaulted me with her fist and blows and hurling dirty languages towards me and my father in law Saidul Islam also joined her, when I tried to save my life and run away towards the gate of the house my father in law hold me at the outside of the gate and assaulted me



brutally by his fist and blow he kicked me on my chest several times, punched on my face and several times kicked on my ankle of right leg, my wife **Rupshad Begam** also joined them and hurling dirty languages towards me and provoked my in laws to kill me. They also threatened me that they will kill me at my rental house where I am presently residing, by hiring supari killers and threatened me that they will go to my workplace i.e., Saktigarh Bidyapith (HS) and assassinate my character in front of my colleagues and students. At that time due to the intervention of the police personnel somehow I manage to save my life. Thereafter I rushed to the Siliguri District Hospital at 20:15 hrs and medically examined by the Medical Officer there and prescribed medicines accordingly. The Emergency medical Slip and the Medicine Bill are annexed herewith this written complaint.

It is pertinent to mention that some part of the incident is recorded in the CCTV camera of Arshad Miah whose house is beside my in laws place/my house located Natun Para, Near Ram Ghat.

At present I am in deteriorate mental condition and in trauma, as because the abovenamed persons are so ferocious that they will not hesitate to kill me. It is therefore requested before you to look after into the matter seriously and take proper strict legal action against the above named culprits.
