Sir,

With due respect and humble submission I ASI Anupam Roy of Siliguri Police Station would like to report before you that yesterday (13.05.2026) at about 05.25 hrs while performing my night Mobile van duty at PS area, I received an information regarding the Road Traffic accident near Fuleswari Bridge under Siliguri PS. I informed the incident to superiors. I along with C/1010 Dilip Barman and HG/179 Shambhu Kamti vide CC No-291/26 Dated -12.05.2026 arrived to the spot, i.e Fuleswari Bridge under Siliguri PS. It is found that (1) One Motorcycle bearing regd. No WB 74 BS 5873 and (2) One Scooty bearing Regd. No WB 73 R 7784 lying on the Bridge in damaged conditions. On enquiry it came to learn that both the vehicles met head to head collision. The both riders sustained injury and the local people shifted them to Siliguri District Hospital for emergency treatment. It further came to learn that due to rough and negligence riding of either vehicle which caused this Road Traffic accident.

Hence, I pray before you that kindly treat this complaint as Suo motto to register a specific case under proper section of law.
