the lock of my house and looted approx 5 gram of gold and  
RS. 20,000/- of cash by breaking the lockers of my house, this  
incident has taken place between 12 p.m to 2 p.m. on 11/05/26.  
The asset which were looted it was in my mother's room.  
She is living with me at my house. and after that incident  
approx at 4:30 p.m, when my youngest (middle brother) has  
come back from duty. he had saw it has happened on  
he informed all of us, and had called the police.

So, I kindly request you to  
investigate it as soon as possible.
