Sir,

In producing herewith two accused persons named Gaurav Kumar Yadav (M/22), s/o- Ajeet Singh, resident of Nagla Pancham, Dhir Pur, PS- Momdabad, Dist- Farrukhabad, Uttar Pradesh- 209743 (Aadhaar No. 8785 3764 4879) & Sumon Uddin Laskar (M/36), s/o- Karim Uddin Laskar, resident of Dudhpatil Pt V, Silchar, PS- Malugram, Dist- Cachar, Assam- 788003 (Aadhaar No. 9997 4563 5384) under custody along with following seized articles:

- (i) One Ashok Leyland DCM six wheeler Truck (container) red in colour displaying No. UP-76AT-3439 along with its ignition key.
- (ii) Seventeen (17) packets articles containing Poppy seeds, each packet weighing 30 KG (total 30 X 17 = 510 KG); out of which one packet is taken out as sample and marked as Exhibit-A.
- (iii) One iPhone11 pro max mobile phone having IMEI No. 353919106018249 of accused Sumon Uddin Laskar.
- (iv) One Samsung Galaxy A35 5G android mobile phone (model No. SM-A356E/DS) having IMEI No. 350115570840597 of accused Gaurav Kumar Yadav.

I, ASI Amit Lama of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested two accused persons to the effect that today on 14.05.2026 at 20:50 hrs I received reliable source information that a huge quantity of stolen Poppy seeds have been transporting in a red colour six wheeler Ashok Leyland DCM truck bearing No. UP-76AT-3439 and the vehicle will proceed to Delhi through AH-02. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide GDE No. 611 dated 14.05.2026 and formed a raiding team consisting SI Samik Paul, ASI Shekhar Lama, VP/01 Anselam Kujur, VP/02 Pradip Roy, CV/386 Kishor Ranjan Howladar, CV/375 Jogesh Barman & CV/389 Janak Singh led by me and left for Singhijhora More beside AH-02 to work out the source information. This refers to MCC No. 1310/26 dated 14.05.2026. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences or facility for the escape of the offenders. At around 21:00 hrs we reached at Singhijhora More beside AH-02 under Bagdogra PS and made an ambush there. After a while source indicated one truck. Accordingly, we apprehended one red colour six wheeler Ashok Leyland DCM truck bearing No. UP-76AT-3439 at around 21:28 hrs and parked the truck beside the road. Two persons were inside the driver's cabin of the truck. We detained them and interrogated them. On interrogation, they disclosed their identity as Gaurav Kumar Yadav (M/22), s/o- Ajeet Singh, resident of Nagla Pancham, Dhir Pur, PS- Momdabad, Dist- Farrukhabad, Uttar Pradesh- 209743 (Aadhaar No. 8785 3764 4879) (driver) & Sumon Uddin Laskar (M/36), s/o- Karim Uddin Laskar, resident of Dudhpatil Pt V, Silchar, PS- Malugram, Dist- Cachar, Assam- 788003 (Aadhaar No. 9997 4563 5384) (cleaner). I then informed them about the input regarding transportation of a huge quantity of stolen Poppy seeds in the truck and asked them but they denied the matter. Accordingly, I arranged to search the truck with the help of accompanying Police personnel in presence of two independent witnesses named Md. Ramjan (M/27), s/o- Late Md. Fakira, resident of Pramod Nagar, PS- Bagdogra, Dist- Darjeeling (Ph. No. 7470111840) and Barun Ray (M/20), s/o- Late Ramsagarat Ray, resident of Singhijhora, PS- Bagdogra, Dist- Darjeeling (Ph. No. 8207274702). On search, seventeen (17) packets articles containing Poppy seeds got recovered from the truck. Then I arranged to weigh the recovered articles and found each packet measuring weight 30 KG (total 30 KG X 17 Pkt = 510 KG). On demand, they could not provide any valid document or purchase in respect of the recovered poppy seeds. Besides,

one iPhone11 pro max mobile phone having IMEI No. 353919106018249 of accused Sumon Uddin Laskar and one Samsung Galaxy A35 5G android mobile phone (model No. SM-A356E/DS) having IMEI No. 350115570840597 of accused Gaurav Kumar Yadav, got recovered. On further interrogation, the driver disclosed that they had procured those poppy seeds without valid document from Guwahati, Assam and had been proceeding to Delhi for its clandestine disposal for their wrongful gain. Thus their involvement is clearly transpired in this case. Accordingly, I seized the recovered articles including the Ashok Leyland DCM six wheeler Truck red in colour displaying No. UP-76AT-3439 along with its ignition key and two mobile phones from their joint possession under proper seizure list in presence of the independent witnesses. At last, I arrested them after communicating them the ground of arrest in writing to prevent the accused persons from committing any further offence, to prevent them to cause disappearance of evidence as well as for proper investigation of the case and issued memo of arrest in this regard. The process of search, seizure & arrest is done in between 21:28 hrs & 21:51 hrs on 14.05.2026. The entire process of search, seizure & arrest is done through audio-video electronic means using Govt. mobile App 'WB E- Sakshya.

Under the above fact & circumstances, I request you to initiate a specific case under proper sections of law against the above mentioned two involved arrested accused persons named Chumir Ali @ Samir Ali (M/34), s/o- Late Bacher Ali, resident of Satmukhi Gaon, PO- Balajan, PS- Baghbar, Dist- Barpeta, Assam- 781308 (Aadhaar No. 8188 1855 5260) & Main Uddin (M/21), s/o- Matiyar Rahaman, resident of Lehi, Nirala N.C, PO- Nirala, PS- Kashumara, Dist- Barpeta, Assam- 781308 (Aadhaar No. 6524 9659 2592) and arrange for its investigation.
