Sir,

In producing herewith two accused persons named Arbaj Alam, aged 23 years, s/o- Md. Muslim, resident of Panjipara, Laskargaon, PS- Goalpokher, Dist- U/Dinajpur (Aadhaar No. 3894 0847 6940) and Sakil Ansari, aged 22 years, s/o- Rafik Alam, resident of Panjipara, Laskargaon, PS- Goalpokher, Dist- U/Dinajpur (Aadhaar No. 5813 2284 8771) under custody along with the following seized articles under proper seizure list:-

- (i) One transparent plastic pouch contains brown colour substance suspected to be Brown Sugar measuring weight 44 (forty-four) grams and marked as Exhibit- A.
- (ii) One black colour Hero Super Splendor motorcycle displaying No. WB74AS/3765 along with its ignition key.
- (iii) One Redmi android mobile phone having IMEI No. 869116060985862 with JIO SIM No. 6296188579 and marked as Exhibit- B.
- (iv) One Samsung Galaxy S23 android mobile phone having IMEI No. 350389911298845 with JIO SIM No. 9832114348 and marked as Exhibit- C.

[Note: Exhibit- A was kept concealed inside Hero Super Splendor motorcycle displaying No. WB74AS/3765

I, SI Debabrata Kundu of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the arrested accused persons named Arbaj Alam, aged 23 years, s/o- Md. Muslim, resident of Panjipara, Laskargaon, PS- Goalpokher, Dist- U/Dinajpur (Aadhaar No. 3894 0847 6940) and Sakil Ansari, aged 22 years, s/o- Rafik Alam, resident of Panjipara, Laskargaon, PS- Goalpokher, Dist- U/Dinajpur (Aadhaar No. 5813 2284 8771) to the effect that today on 15.05.2026 at 21:05 hrs I received a specific source input that two suspects have been waiting near Kestopur railway gate with a black colour motor cycle (Hero Super Splendor) displaying No. WB-74AS-3765 and they have possessed & carried substance suspected to be Brown Sugar to deliver the same to their prospective buyers of Halal busty. They could be caught in red-hand if raided immediately. The matter was diarized vide Bagdogra PS GDE No. 657 dated 15.05.2026 and I informed the matter to the Officer-in-Charge of Bagdogra Police Station, S.P.C. As per his kind direction a raiding team is formed consisting ASI Amit Lama, ASI Shekhar Lama, VP/01 Anselam Kujur & CV/386 Kishor Ranjan Howladar, all of Bagdogra PS, S.P.C being headed by me and at 21:15 hrs we left for Kestopur railway gate under Bagdogra PS by Govt. vehicle No. WB61A/0137 with investigation kit to verify the veracity of the information in hand vides Bagdogra PS GDE No. 658 dated 15.05.2026 and M.C.C. No. 1313/26 dated 15.05.2026. On the way, I contacted with two independent witnesses named Liton Sanyasi, aged 33 years, s/o- Arun Sanyasi, resident of Choupukuria, Kestopur, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9832385723) and Ananda Biswas, aged 25 years, s/o- Late Gautam Biswas, resident of Choupukuria, Kestopur, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9564532407) and issued them notice in writing to remain present with us as independent witness for the purpose of search, seizure, arrest, if any. They expressed their willingness to remain present with us as independent witness. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences or facility for the escape of the offender.
