Sir,

In producing herewith one arrested person who disclosed his identities namely Dipankar Roy @ Gusti (26 yrs) S/O Late Monu Roy of Bhabasindhu Colony near Radio Centre, PS- Bhaktinagar, Dist- Jalpaiguri along with the seized articles as per seizure list;

1. One improvised one shutter iron made fire arms measuring approx 10 inches from barrel to butt having striking pin, hammer and trigger from possession of accused Dipankar Roy @ Gusti marked as Exhibits- 'A'
2. One live ammunition engraved O.K 20 7Z unreadable on its percussion cap (found loaded in SI No.1 ) seized exclusively from possession of accused Dipankar Roy @ Gusti marked as Exhibits- 'A1'
3. One live ammunition engraved O.K 20 7Z unreadable on its percussion cap (which was kept concealed in the right pocket of trouser pant of accused Dipankar Roy @ Gusti) seized exclusively from possession of accused Dipankar Roy @ Gusti marked as Exhibits-A2

I, SI Youel Lepcha of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Dipankar Roy @ Gusti (26 yrs) S/O Late Monu Roy of Bhabasundar Colony near Radio Centre, PS- Bhaktinagar, Dist- Jalpaiguri that on 15.05.26 around 20.55 hrs, received a secret source information that one person had been spotted with firearms at N.H 10 near Gandhi Maidan ward no.43 under Bhaktinagar PS with an intention to commit heinous crime. Diarised the mater vide Bhaktinagar PS GD Entry No.1683 dated 15.05.26. As per your kind instruction of I/C Bhaktinagar PS, at 21.05 hrs I along with SI Uday Chakraborty, PSI Sahanur Rahaman, ASI Dhruba Mishra, C/374 Debaraj Biswas all Bhaktinagar PS rushed to spot as per the order I called K37 Van officer ASI Arjun Prasad Dhyani along with his team to come the spot to work out the information.

After arriving there I approached two persons to accompany us and they agreed to accompany the raid namely 1) Suresh Ram(40 yrs) S/O Sankar Ram of Prokash Nagar Sahani Busty, ward No.43 PS- Bhaktinagar, Dist- Jalpaiguri, 2) Shaswat Choudhury (22 yrs) S/O Ranjit Kr. Choudhury of Ganghi Nagar, Ward No. 43, PS- Bhaktinagar, Dist- Jalpaiguri As identified by my source, at about 21.25 hrs we found that the above noted person was moving suspiciously at N.H 10 near Gandhi Maidan under Bhaktinagar PS. On seeing the police party he tried to escape from the place. But we apprehended one individual. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he was in the N.H 10 near Gandhi Maidan under Bhaktinagar PS with an ulterior motive. Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Dipankar Roy @ Gusti was made on search and found that One improvised one shutter iron made fire arms measuring approx 10 inches from barrel to butt having striking pin, hammer and trigger from possession of accused Dipankar Roy @ Gusti marked as Exhibits- 'A', One live ammunition engraved O.K 20 7Z. unreadable on its percussion cap (found loaded in SI No.1) seized exclusively from possession of accused Dipankar Roy @ Gusti marked as Exhibits- 'A1', One live ammunition engraved O.K 20 7Z unreadable on its percussion cap (which was kept concealed in the right pocket of Trouser pant of accused Dipankar Roy @ Gusti) seized exclusively from possession

of accused Dipankar Roy @ Gusti marked as Exhibits-A2. The Sl. No. 1 was kept concealed under the accused person's waist of his Jeans Pant on the Right side. The ammunition was unloaded from the firearms as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Dipankar Roy @ Gusti made incoherent statements and failed to produce any valid documents in support of said seized Firearms. As there is every reason to believe that the firearms and ammunitions recovered has been procured dishonestly by the apprehended Dipankar Roy @ Gusti for his ulterior motive, seized and labelled the firearms and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person and arrested him following all formalities. The seizure and label was made in-between 21.30 hrs and 22.25 hrs. On being further asked the arrested accused person admitted that he used purchased the same from Bihar state and sold the same to his design customer for his wrongful gain.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested Dipankar Roy @ Gusti (26 yrs) S/O Late Monu Roy of Bhabasindhu Colony near Radio Centre, PS- Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
