I Sri Lakshman Haldar, Son of Late Kalipada Haldar, Resident of Kholachand Papri, Post Office Salugara, P.S Bhaktinagar, District Jalpaiguri, that on 15/03/2025 at about 3-3.30 p.m, when I along with my wife and some other villagers were standing in front of my house the above named persons along with some other anti social elements in scooty and motor bikes suddenly came in drinking condition and they used slang languages and also bitten some of the local villagers and they were seriously injured. That time we went to the spot and tried to manage and settle the dispute in between them for peace in our locality, but suddenly they became more aggressive and started biting me and my wife. In their said act and conduct, my wife was seriously injured and the villagers took her to the Siliguri District Hospital for treatment, after medical examination the doctor prescribed some medicine.


That it is stated, I was engaged with my wife's treatment, so I was unable to visit and consult the doctor on the said date but on 16.03.2025, I went to the Siliguri Sadar Hospital for my treatment and gradually my health got

detoriated. That it is also stated that the above named persons fled away and left the scooty being number WB 74 AL 8316 which is kept in my house.

In the above fact and circumstances, I request you to take legal action against the above named persons for proper justice.


