It is pertinent to mention here that our neighbor namely Santu Saha, Son of Badal Saha and Khokan Ghosh, Son of Biswanath Ghosh since long use to create "**Jhamela**" with our family members and to that score my elder sister namely Laxmi Saha Paul lodged a specific police case against them vide Bhaktinagar P.S. Case No.06/25 dated 02.01.2025, U/S 126(2)/115(2)/117(3)/74/351(2)/3(5) of BNS Act and after lodging the said case the above named persons alongwith their antisocial friends at a regular course of intervene use to threatened me and my family members with dire consequences and for that sole of reason we used to passes our daily life with get fare and anxiety.

It is to be noted here that today at about 7:00 a.m. when I had been to Ashighar Jaykanta School Math for morning work then all on an sudden said Santu Saha and Khokan Ghosh and their antisocial friends started to assaulted me with lathi, Chaku and etc. without any rhyme and reason and out of the said incident I sustains serious blood injury throughout of my body and soon after then I was taken to Siliguri District Hospital for my



immediate treatment (the Xerox Copy of Treatment Slip of Siliguri District Hospital is annexed herewith for your kind perusal).


