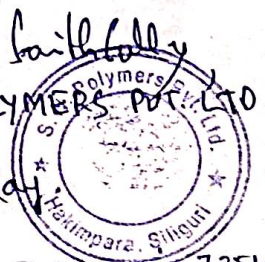
I humbly request you to kindly register the complaint & take necessary steps and also take the handover of the above mention bike.
