Subject: Written Complain regarding Theft in my house

Dear Sir,

With due respect, I the undersigned would like to inform you that my daughter-in-law Smt Ruchi Singhal Agarwal has lodged a written complaint on 30.01.2025 to the Officer In-Charge, Uttorayon Outpost against her husband, myself, my wife and my younger son and on the basis of the said complaint one case has been registered being Matigara Police Station case no. 65 of 2025 under section 85/304(2)/115(2) of B.N.S., 2023.

After lodging the said complaint dated 30.01.2025, my daughter-in-law along with her mother Smt Nilam Devi Agarwal, her sister Rimpa More, her sister's husband Dipak More and her brother Bunty Singhal have all suddenly entered into my house and started to abuse filthy languages and on protest they assaulted me and my younger son and threw us out from my residence and somehow we managed to save our lives and took shelter here and there living in the mercy of our relatives. My daughter in law and her said family members have forcefully and taken unlawful possession of my residence and all valuables. After securing the bail from the learned court in connection with the Matigara Police Station case no. 65 of 2025 on 05.02.2025, my daughter-in-law and her said relatives have threatened us by saying that if I along with my family members try to enter into my house, they will again implicate us in other false and heinous criminal cases.

Due to such threatening and other illegal activities of my daughter-in-law and her family members, my wife Smt Kanta Agarwal has lodged a written complaint on 06.02.2025 to the Officer In Charge, Uttorayon Outpost against my daughter-in-law and her family members and on the said complaint once case has been registered being Matigara Police Station Case no. 88 of 2025 u/s 329(4)/115(2)/117(2)/351(2)/3(5)/303(2) of B.N.S, 2023.

I would like to further inform you that after being ousted from my own residence by my daughter-in-law and her family members, I have approached the Commissioner of Police, Siliguri Police Commissionerate requesting for police protection so that I could enter into my own house. However, after police protection was refused, I along with my wife have filed one writ application before the Calcutta High Court, Circuit Bench at Jalpaiguri against my daughter-in-law and her family members being W.P.A No. 412 of 2025 and after hearing the matter, Hon'ble Justice Amrita Sinha vide her order dated 01.05.2025 was pleased to direct me and my wife to return in our house and also directed my daughter-in-law to restrain

herself to her room and let us live peacefully in our house along with some other directions therein.

I would like to further inform you that before entering my house, my wife has duly communicated in writing to the Matigara Police Station regarding the said order dated 01.05.2025. Thereafter, I along with my wife went to our house and requested my daughter in law to open the gate. However, we received a lot of resistance from her and she did not let my younger son enter the house at all. Upon entering the house, we found that my daughter-in-law and her said family members have made a duplicate key and opened the wooden almirah in the ground floor room, in which the keys to all our other almirah's lockers and drawers were kept. After opening the said almirah, I found that the following valuables have been stolen by my daughter-in-law and her said family members:

I would like to further inform you that all the bills and money receipts for the above listed valuables have also been taken away by them. Some of the abovementioned valuables were our antique ancestral ornaments. The total market value of the aforementioned valuables is worth approximately Rs. 80,00,000/- (Rupees Eighty Lakhs only).

Apart from the above, I found that my daughter-in-law and her family members have removed all the old locks from the main entrance of our house, almost each and every bedroom and installed new locks. I also found that the Hard Disk drive and DVR of our

CCTV cameras has been removed, and new CCTV cameras have been installed in our house.

I would like to further inform you that soon after our arrival into our residence, my daughter-in-law's mother, sister and her sister's husband were present there and when we asked our daughter in law regarding all our missing valuables and changed locks in the house, she started to shout very loudly and misbehave with me and my wife. Thereafter, she locked us out of our house again. I informed the matter to the Matigara police station and due to the intervention of the police officers, after being locked out of the house for more than 1 hour, she finally opened the door of the house. However, after the said police officers left, she along with her family members again started to misbehave with us and started to shout very loudly to humiliate us further in the neighborhood. Being an aged person with several ailments, I have started to feel very unsafe and for avoiding further complications, I left my place with my wife for a moment.

Under the above circumstances, I would request you to please investigate the matter in detail and the do the needful for recovery of my valuables from the illegal custody of my daughter in law and her family members for the ends of justice.
