With due respect, I Jiwan Kumar Prasad (34/yr)
S/o - Sudhir Prasad of Champasari Anchal near Post-office
Ward No-46, P.S- Pradham Nagar (Dist: Darjeeling) would
like to inform you that we have grocery shop situated at
Champasari Anchal near post-office. My mother namely
Sunita Devi give the grocery items on credit from
last two years and total amount remaining ₹35,000/-
and given rest amount - when they were suffering from
disease. Total amount was given to Lakhi Pandey
family approx amount ₹2,00,000/- and they have given
return one cheque amount - ₹2,00,000/- in the name
of Sunita Devi. They also said that when I will sell my
land then I will pay all money, but they sold their
land and till now they didn't pay any money to my
mother.

Yesterday i.e. 23/05/2025 at about morning time
10:30 hr my mother went at their house they misbehaved
with my mother and also say that - I will not give
any amount - to you and they quarreled with my mother.
At night 23:30 hr Lakhi Pandey son who name Vishal
Pandey came at our house along with eight boys
and started shouting in main gate. When my mother
go outside then the alleged person hit and pushed
my mother and forcefully entered into the house.
They all were came at my house in intention to
fight - with us. They started fighting and assaulted
to all our family members.

Written by me also read over
in his vernacular language.

The alleged persons use filthy language upon my wife and other ladies hit them in wrong intention.

As a result - I and my family members received several injury and treated to Sirguri District Hospital. Further the alleged persons threatened for -
"Ab paisa mangne aya to ab kuch qahi hua hai abhi bahul - kuch hoga baki hai".

There, I will be very glad if you grant my prayer and take necessary action against them.
