I Gopal Sen, the above noted Complainant beg to inform you that I am a Baby Food, Cosmetics & Sanitary Napkins wholesale dealer and having my godown, in front of my house at Subhash Pally and above noted alleged person was working under me from last 03 (three) years.

On Dt. 23.05.2025 at 12:30 pm, I sent him to my godown to bring 04 cases of Softy female's Sanitary Napkins, but he took out 04 (four) cases of Softy Napkins and additionally 01 (one) case of Stayfree female's Sanitary Napkins containing 84 (eighty four) pieces and sold said 01 (one) case Sanitary Napkins to someone on the way and brought 04 (four) cases of Softy Sanitary Napkins.

I came to know this fact because my wife namely, Dipika Sen (33), Saw this from my house and took photograph of 05 Cases of Napkins from her mobile phone. Thereafter I enquired it with him, but he managed to escape from there.

Then I checked my stocks over my computer and came to know that he had stolen away, the goods costing Rs 5,76,700/- (Rupees five lacs seventy six thousand seven hundred) only from my said godown at Subhash Pally, Ward No. 20, P.S. - Siliguri, from last 06 (six) months.

So, Please take necessary action against said culprit namely Kailash Ram, noted above.

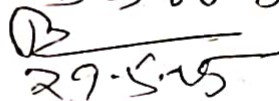
