I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpura CCC, WBSEDCL, Siliguri do here by lodge complaint against Akash Bose, S/O- Nirmal Bose & Anikesh Agarwal S/O- Vijay Kr Agarwal (Ph No- 8391056161 & 9635057111), Ram Krishna Road, Ashrampara, Ward No.-14, Siliguri, Dist- Darjeeling, Pin- 734001 for having committed offence as stated here under.

On 26.06.2025 at about 01.06 PM. acting on a source information I, along with 1) Sri Bijay Lakra, D.E., S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Bhoben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Linesman, Hakimpura CCC and other officials of WBSEDCL entered the residential premises of Asit Kumar Deb and inspected service installation, metering installation of Consumer ID 403095609 in the name of Asit Kumar Deb. During inspection it was found that present user Akash Bose & Anikesh Agarwal are using electricity unauthorisedly & illegally by reconnecting the disconnected service line of the metering installation that was disconnected previously on 09.06.2025 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 39068.00 (Rupees thirty nine thousand sixty eight only) including the LPSC of Rs. 507.00 (Rupees five hundred seven only) till the date of 26.06.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Schneider Electric India P L, serial no.- SE0562782 installed against Con Id. 403095609, seized by preparing a formal seizure list duly signed by witnesses. As Akash Bose & Anikesh Agarwal they have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
