Sir,

With due respect and humble submission, I beg to report before you that I, ASI Dipak Karmakar s/o Dulal Karmakar of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodged this written complaint against following persons to the effect that on 29.06.25 at about 01.20 hrs while performing PS night mobile van duty had been to ANGEL RCB Additional Bar (VIP Restro Bar) situated at Sevoke road near Check post under Bhaktinagar PS for routine visit of closing Bar in time at 01.00hrs as per order of The Superintendant of Excise, Jalpaiguri vide order no-1425/E Dated 28.06.25 and found that the Bar was running in that time after violation of permission by Excise department, Govt of West Bengal, The Bar was running up to 01.25AM after violating the Govt order. I checked the CC Camera footage where I found the Bar was running up to 01.25AM after violating the Govt order.

During enquiry it came to learn that one Mr Arunesh Kumar Sha @ Umesh s/o Shri Shambhu Sha and Mahesh Kumar running that bar and Pab after violating govt order. I tried to serve notice u/s 35(3) BNSS but they are fled away from the spot. I also video graphed the scene with my mobile camera.

I therefore pray that a specific case may kindly be initiated against the accused persons viz. (1) Mr Arunesh Kumar Sha @ Umesh s/o Shri Shambhu Sha and Mahesh Kumar under proper sections of law.
