Respected Sir, I, SI. Arup Singh serving under your kind disposal filling this written complaint against 5/6 (Five/Six) unknown persons to the effect that on 18.07.2025 at about 11:15hrs the authority of Siliguri Municipal Corporation, Siliguri started demolition of illegal structure at the site of Sri Vim Roy of Promod Nagar Colony, Ward No-18 of SMC, PS- Siliguri, Dist- Darjeeling and to avoid any untoward incident and maintaining Law and Order of the area, myself along with SI Bhiswadeb Barman, SI Biswajit Ghosh, C/855 Utsab Guha, C/863 Ranjit Rai, LC-1283 Munu Chhetri, LC-1960 Ruma Das and others along with 01 section of composite force were deployed in the said area vide GDE No-1151 Dated-18.07.2025. Till 12:05 hrs the situation was peaceful but after that five/six unknown persons gathered there and started obstruction to perform the Govt. duty of the SMC authority by disobeying Govt. order and also breached the peace of the area. Accordingly, I intervened and tried to stop them and to control the situation also stated them that they illegally obstructed the Public servant to perform their duty and disobeying the Govt. order but they did not pay any heed towards the words of mine as well as the on-duty Police personnel, in presence of Police they became aggravated and tried to make Law and Order situation in that area and wasting no time myself along with force went to stop them and they disobeyed the lawful direction of Police. Seeing the grievousness of the situation myself along with all officer and force immediately intervene and by convincing make them understand to disperse from the area and managed to take control of the situation.

Further, I found that one Amrit Podder spread false information regarding this incident in various platform which may imbalance the harmony of the area.

Therefore my humble request before you that a specific case may kindly be initiated against 5/6 unknown persons for disobeying the direction of public servant and obstruct them to perform their Govt. duty and also against Amrit Podder for spreading false information regarding the incident.
