Sir,

In producing herewith one arrested accused person namely Md. Akbar Ali(M/24), S/O-Lt Md. Ramzan Ali of Digravita, PS-Bagdogra, Dist-Darjeeling and one seized Tractor bearing reg. no. WB-73K-1018 loaded with river bed materials i.e Sand".

I ASI Ashish Karmakar of Bagdogra Police Station, Siliguri Police Commissionerate do here by lodge this written complaint to the effect that on 26/07/25 while I along with C/778-Kamal Lama and C/283-Dani Barman were performing morning mobile van duty vide Bagdogra PS GDE No-1168 and MCC No-2384/25 dated-26/07/25 at about 10.20 hrs I received a secret source of information that one Tractor loaded with river bed materials is coming from Hansqua side towards Bihar More to illegally disposed the same. Accordingly, I informed the matter to on duty GDE officer as well as the O/C Bagdogra PS and as per his kind direction we immediately left for Kolkata Road on Army Track Marshall under Bagdogra PS to verify the veracity of the information. On arrival at about 10.30 hrs near Army Track Marshall on NH-27 we waited for the said tractor to arrive and after some time at about 10.35 hrs as indicated by source we noticed that one tractor is approaching towards us from Bhuttabari side but seeing the police team the driver of the offending Tractor speeded the tractor. We signaled the driver of the said tractor to stop but he/she did not have any response to police personnel. We started to move near the tractor with repeated signals to stop but as soon as we tried to reach near the said tractor, the driver of the said tractor speeded and tried to flee away but after a hot chase we managed to intercept the said tractor having reg. no- WB-73K-1018 and also managed to apprehend the driver near the service road at Army Track Marshall on NH-27. I then searched and found that the said tractor bearing reg. No. WB-73K-1018 was loaded with "river bed materials i.e Sand". I also searched for any valid paper/documents but did not find any in favour of the said tractor as well as for the material. On asking the driver of the said tractor disclosed his name and identity as Md. Akbar Ali(M/24), S/O-Lt Md. Ramzan Ali of Digravita, PS-Bagdogra, Dist-Darjeeling. On asked. On request he could not produce any valid documents and paper in respect of the said tractor as well as for the materials. There is a strong reason to believe that the said Tractor loaded with "river bed materials i.e Sand" was stolen by the driver/owner of the said tractor by fraudulent means to clandestinely dispose of the same to their designated customer. Finding no other alternative, I seized the said Tractor bearing reg. no. WB-73K-1018 loaded with river bed materials i.e Sand from the PO i.e near the service road at Army Track Marshall on NH-27 as per proper seizure list in presence of police witnesses after maintaining all formalities of seizure. As per provision the entire process of search and seizure was made by audio/video electronic means which was converted into a Pen Drive and attached herewith. The search & seizure was made in between 10.45 hrs to 10.50 hrs on 26/07/25.

Therefore I pray before you to start a specific case against the driver namely Md. Akbar Ali(M/24), S/O-Lt Md. Ramzan Ali of Digravita, PS-Bagdogra, Dist-Darjeeling and the owner of the seized tractor bearing reg. no. WB-73K-1018 loaded with river bed materials i.e Sand" under proper section of Law and arranged for its investigation.
