Pharov Champabari Anchal attached to S.T. Girls
Hostel, near Siriguri School. Woul'd like to inform
you that around 1.30 PM my mother Shanti
Dewi Pharov went to her house. Rani Kumari
did not allowed to enter inside the house
and drag her into ground. Rani Kumari opened
my mother's sari and made her naked and tied
her throat with sari and chupatta with
intent to kill her. Rani Kumari threw
brick and stone on my mother.

As a result my mother became serious
immediately with the help of local people shifted
her to Malabar hospital and presently she is
admitted to Mangal hospital in serious
condition.

Rani Kumari used abuse I longers and said
that if my mother will enter in her house
again Rani Kumari will set fire and burn
whole building and also blackmail that she will
commit suicide.

Sir Rani Kumari is staying forcefully and
unauthorisedly into my mother house. Sir my
mother is seventy three yrs old lady suffering
from heart disease.

With above mention incident my mother
has gone to Depression and Nephrotic.
