Subject: Complaint against attempt to murder, snatching and extortion

Sir,

I Sri.Shuvrayan Saha , S/O.Sri Sanjay Saha resident of Bhaktinagar , Near Ghosh nursing home , NJP , Siliguri - 734007 beg to state that

- 1.Yesterday I along with my friend Avi Saha went to Firangee Club situated at sevoke road at around 1:30 am and we went out of the club at around 2am .
2. At the parking lot when we were about to leave the club premises we went towards the parking lot
3. There were around 10 miscreants assembled there in the parking lot and was whispering pointing at us at low voice .
4. As soon as we entered the parking lot suddenly a white coloured Bolero came in high speed towards me and almost hit me . I asked them to drive carefully but those 10 peoples came running towards me one of them saying "amar lok ache amake bol"
5. And from nowhere they started hitting us with fists and blows and started to hit me with iron rods and sharp edged weapons .
6. We somehow managed to flee from the spot in our motorcycles dripped in blood .
7. They then followed us and stopped us near bottle company more in their bikes and as soon as we stopped they came running towards us and started hitting us again with sharp edged weapons .
8. Their utmost target was to kill us and in the process they also snatched our mobile phones , gold rings , and cash which was present in our pocket .
9. Details of articles snatched is as follows : Cash combined 32,000 , two gold rings weighing 9 grams , one Iphone XR of me and one Galaxy S24 Ultra having IMEI number : 1. 353578852671641 , 2.353578852671641 .
10. We fell unconscious through the process and was laying on the road and somehow we managed to reach Siliguri District Hospital at around 3 am where we got us treated and took the medical slip .

11. There are prominent marks of physical torture on both our body and a prominent choke mark on my neck when they tried to kill me by chocking my neck . Leaving nail marks all over my neck and also my teeth got misplaced by their blows .

12. We can recognise two persons among them namely 1. Rintu Sarkar of Payel more area
2. Amit Roy of Payel more area associated with many other antisocials of Bottle company .

13. They also threatened me that if we go to police station they will kill us in future as they don't fears the police authorities.

Sir, I hereby request you to kindly take action against these miscreants under proper book of law and recover my stolen articles and also help me get security and justice from your good office and oblige .
