In producing herewith following five arrested accused persons namely (1) Alamgir Mondal Seikh- 28yrs s/o Yunush Mondal of Asrfnagar, Kotkoti more ward no-40,PS Bhaktinagar, Dist Jalpaiguri (2) Rohit Sewa-25yrs s/o Bimal Sewa of Choto Fapri, PS Bhaktinagar, Dist Jalpaiguri and (3) Niranjan Mondal-23yrs s/o Lt Gopal Mondal of Ghorar bari, Bhola More, PS NJP Dist Jalpaiguri (4) Rahul Mondal-23yrs s/o Raju Mondal of Prakashnagar, near Military Ghat, ward no-43 PS Bhaktinagar Dist Jalpaiguri (5) Rajesh Das-25yrs s/o Ratan Das of Gourangapally, Tingach, ward no-40 PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- One sharp cutting knife with wooden butt measuring approx 11 inches recovered from the exclusive and Conscious possession of Niranjan Mondal.
- 2) One iron Hammer measuring approx 11 inch recovered from the exclusive and Conscious possession of Alamgir Mondal Seikh.
- 3) One screw driver measuring approx 11 inch recovered from the exclusive and Conscious possession Rahul Mondal.
- 4) One Plus (Tools) measuring approx 8 ½ inch recovered from the exclusive and Conscious possession of Rohit Sewa.
- (5) One Iron made adjustable wrench measuring approx -7" recovered from the exclusive and conscious possession of Rajesh Das.
- I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 28.08.2025 at 00:05 hrs received a specific source information that 11/12 miscreants have assembled at Eastern bypass road, near Himalaya Kanya Abasan under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No. 1144 dated 28.08.25 and as per order I along with SI Youel Lepcha, ASI Dipak Karmakar, ASI Dhurbo Misra, ASI Mukul Basu with force (K-37 PS Mobile) and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Eastern bypass road, near Himalaya Kanya Abasan under Bhaktinagar PS to work out the information in hand vide GDE No-1145 dated 28.08.25.

At about 00.25 hrs we arrived at the at Eastern bypass road, near Himalaya Kanya Abasan as indicated by the source we noticed that 7/8 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 05 (five) of them with deadly weapons

in their possession but 4/5 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapons of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 28.08.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Alamgir Mondal Seikh- 30yrs s/o Ynush Mondal of Asrfnagar, Kotkoti more ward no-40,PS Bhaktinagar, Dist Jalpaiguri (2) Rohit Sewa-25yrs s/o Bimal Sewa of Choto Fapri, PS Bhaktinagar, Dist Jalpaiguri and (3) Niranjan Mondal-23yrs s/o Lt Gopal Mondal of Ghorar bari, Bhola More, PS NJP Dist Jalpaiguri (4) Rahul Mondal-23yrs s/o Raju Mondal of Prakashnagar, near Military Ghat, ward no-43 PS Bhaktinagar Dist Jalpaiguri (5) Rajesh Das-25yrs s/o Ratan Das of Gourangapally, Tingach, ward no-40 PS Bhaktinagar Dist Jalpaiguri and 4/5 others also arrange for its investigation.
