I, Mayank Agarwal S/o Jagdish Agarwal, resident of Alu Chowdhury More would like to lodge a serious complaint regarding heinous incident of physical assault, attempt to murder and criminal intimidation against me.

Incident Details :

On 21 Sept 2025 around 2:00 Am near planet mall, seroke road, Siliguri. I was brutally assaulted by a group of 8-10 people without any reason as they were ~~dr~~ fully drunk and tried to provoke me. Among them two individuals whom I can ~~clearify~~ clearly identify are:-

- 1/. Chirag Bansal:- PHNo - +91 8250373381
- 2/. Sahil Kashyap:- PHNo - ~~91~~ 6296543475.

These two persons led the attack and inflicted

severe injuries upon me including serious damage to my left eye. They along with there associates not only beat me mercilessly but also threatened me that they will kill me the next time they see me.

It is also to be noted that the owner of pub (Hashtag) in Planet Mall and their bouncers supported the accused persons during this incident. I am under immense mental trauma and physical trauma due to repeated threats for my life.

I request you to kindly register this complaint and take strict actions against the "Chinag Bansal", "Sahil kashyap" and the bouncers. Tha
