Sir,

In producing herewith 03 (three) arrested accused persons named (i) Sainik Nandi (23 Yrs) S/O Liton Nandi of Subhas Pally, w/no. 19, Milan Mandir Road, PS-Siliguri, Dist.-Darjeeling, (ii) Sanjib Mahato (39 Yrs) S/O Lt. Raja Mahato of Shitalapara, W/No. 31 near Primary School, PS-NJP, Dist.-Jalpaiguri and (iii) Ram Ghosh (24 Yrs) S/O Swapan Ghosh of Bagrakote, W/NO. 18, Srabannagar, PS-Siliguri, Dist.-Darjeeling along with following seized articles (1) One heavy weight Hammer made of Iron with wooden handle, recovered from the possession of Sanjib Mahato (39 Yrs) S/O Lt. Raja Mahato of Shitalapara, W/No. 31 near Primary School, PS-NJP, Dist.-Jalpaiguri which he was holding in his right hand, (2) One Sword (sharp cutting weapon), measuring approx 30" including its wooden handle, recovered from the possession of Sainik Nandi (23 Yrs) S/O Liton Nandi of Subhas Pally, W/No. 19, Milan Mandir Road, PS-Siliguri, Dist.-Darjeeling which he was holding in his hand and (3) One small electronic torch, red in colour, recovered from the possession of Ram Ghosh (24 Yrs) S/O Swapan Ghosh of Bagrakote, W/NO. 18, Srabannagar, PS-Siliguri, Dist.-Darjeeling which he was holding in his hand.

I, ASI. Abhradip Das of Panitanki TOP (Under Siliguri PS)/SPC, do hereby lodge this written complaint to the effect that on 14.10.2025 at 00.05 hrs. I have received secret source information that 10-12 persons were assembling at the back side of Surya Sen Park beside bank of River Mahananda, Mahakal Pally, Siliguri and making preparation to commit dacoity at the nearby locality. Accordingly, I conveyed the same to O/C, Panitanki TOP, SPC and noted the fact in GD book vide Panitanki TOP GDE No. 275 dt. 14.10.25. Then as per direction of O/C, Panitanki TOP myself along with ASI. Biswajit Ghosh, ASI. Surojit Mallick, ASI. Man Mohan Barman, C/739 Dilip Mitra, C/899 Somnath Roy & C/233 Nagen Ch. Barman left for Surya Sen Park beside bank of River Mahananda, Mahakal Pally, Siliguri to verify the veracity of the information. In the meanwhile I managed to call two independent witnesses namely (i) Pallab Nandi@Bittu S/O Shyamal Nandi of Bidyachakra Colony, W/No. 44, PS-Bhaktinagar, Dist.-Darjeeling & (ii) Subhamoy Biswas S/O Tanmoy Biswas of Lala Lajpat Roy Road, Ashrampara, W/No. 14, PS-Siliguri, Dist.-Darjeeling and request them to accompany with us for search & seizure, if any. Near about 00.25 hrs., myself along with police party & witnesses arrived near Surya Sen Park, Siliguri and kept our vehicle at a reasonable distance and proceed towards bank of River Mahananda behind Surya Sen Park, Siliguri. Upon arrival, being indicated by the source it is found from the considerable distance that a gang of 10-12 persons assembled behind the Surya Sen Park, Siliguri in the bank of River Mahananda, Siliguri and they were whispering in very low voice. Accordingly, we cordoned the place properly and approached towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase we have manage to apprehend 03 (three) persons but others managed to flee away from the spot. On interrogation, the apprehended persons disclosed their name, address as noted above and started giving incoherent statement regarding their presence/gathering in the said place at that odd hour of night. On further grilling they stated that they along with 10 other fellow miscreants assembled there and making preparation to commit dacoity in the locality. Later on being search in presence of the independent witnesses, I have recovered (1) One heavy weight Hammer made of Iron with wooden handle, recovered from the possession of Sanjib Mahato (39 Yrs) S/O Lt. Raja Mahato of Shitalapara, W/No. 31 near Primary School, PS-NJP, Dist.-Jalpaiguri which he was holding in his right hand, (2) One Sword (sharp cutting weapon), measuring approx 30" including its wooden handle, recovered from the possession of Sainik Nandi (23 Yrs) S/O Liton Nandi of Subhas Pally, W/No. 19, Milan Mandir Road, PS-Siliguri, Dist.-Darjeeling which he was holding in his hand and (3) One small electronic torch, red in colour, recovered from the possession of Ram Ghosh (24 Yrs) S/O Swapan Ghosh of Bagrakote, W/NO. 18, Srabannagar, PS-Siliguri, Dist.-Darjeeling which he was holding in his hand.

Subsequently, I have seized the above noted recovered articles as per seizure list in between 00.50 hrs. and 01.05 hrs. in presence of the above said witnesses and duly signed by them and then I have arrested the said three accused persons U/S 35(1) of BNSS after explaining each of them about ground of arrest and the charges against them.

Hence, under the above noted fact and circumstances, I pray that a specific case may kindly be started against (i) Sainik Nandi (23 Yrs) S/O Liton Nandi of Subhas Pally, W/No. 19, Milan Mandir Road, PS-Siliguri, Dist.-Darjeeling, (ii) Sanjib Mahato (39 Yrs) S/O Lt. Raja Mahato of Shitalapara, W/No. 31 near Primary School, PS-NJP, Dist.-Jalpaiguri and (iii) Ram Ghosh (24 Yrs) S/O Swapan Ghosh of Bagrakote, W/NO. 18, Srabannagar, PS-Siliguri, Dist.-Darjeeling and others under proper Section of law and arrange for its investigation.
