Subject: Complaint against my husband his family members for cruelty, dowry harassment, forced religious conversion, and physical assault.

Respected Sir/Madam,

I, Anisha Oraon, daughter of Mr. Matlu Oraon, presently resident of Newmal Railway colony Quarter no 35/A Malbazar, respectfully submit this complaint against **Husband: Mark Kujur** (Ph no 6297506360, address : Shiv Mandir Bidhanpally – Bara Mohan Singh Sporting Club, P.O. & P.S. Matigara, District Darjelling Pincode: 734013) and his family members that is father **Peter Kujur**, mother **Florencia Kujur**, and brother **Birender Kujur** for subjecting me to continuous cruelty, harassment, illegal dowry demands, and forcing me to change my religion against my will.

1. Background and Marriage Details

I am a Hindu by birth. I first met Mr. Mark Kujur in 2021 through Facebook. During this period, my husband and his family forced me to convert to Christianity in September 2021 without my consent, causing immense mental distress.

After forcefully converting me to Christian, we were married on 2nd May 2022, as per Christian rites and customs. My husband, Mark Kujur, who is a Government school teacher. The total expenditure on the marriage was ₹5,00,000, which my family arranged to the best of their ability. After marriage, I started residing with my husband, his father Peter Kujur, mother Florencia Kujur. and brother Birender Kujur (age 31) at their family residence.

2. Chronology of Cruelty and Harassment

Incident on 4 May 2022 (around 10 PM): Just after 2 days of marriage, my husband Mark Kujur, while intoxicated he shouted at me, demanding that I bring ₹2,00,000 from my parental home as dowry if I wanted to stay with them. When I refused, he slapped me, and stated that I must follow what he says and he also said that I should be kicked out of the house if I did not bring the demanded dowry. - I pleaded for help, but they ignored me, I kept crying whole night.

Incident on June 2022: My brother-in-law Birender Kujur demanded that I buy him a bike, claiming it was part of the dowry as he is my husband's brother. When I said I did not have money, he pulled my hair and slapped me, shouted at me, and threatened to throw me out of the house. This incident left me mentally traumatized and depressed. When I told my husband

about the brother-in-law incident, he called his parents and brother-in-law, he also slapped me, and said, "You didn't give us any dowry. Now if you don't fulfill our demands, we will throw you out of the house."

Incident on November 2022: - In the afternoon, I served lunch to my brother-in-law Birender Kujur and his parents. Birender Kujur throw the plate, said "What have you made?", and pulled my hair. My mother-in-law Florencia Kujur and father-in-law Peter Kujur also beat me badly, saying, "Neither you can cook good food nor give us money; we will kill you." When my husband returned home in the evening, I told him about the incident. Instead of supporting me, he sided with his parents and beat me at night after drinking. Then I slept whole night in the open without a house and pleaded I don't have a house but they didn't listen

Incident during pregnancy:

1. I was washing clothes of my mother-in-law (Florencia Kujur), she picked one cloth and said you don't know even to wash the clothes and pulled my hair dragged me in the floor and beat me very badly and said 1 lakh rupaya de nahi toh mera beta ko chhor de.
2. While I was pregnant, my husband Mark Kujur physically beat me and he wanted to abortion my child. He verbally abused me, saying, "I'm fed up of you; I now need a new woman," and called an escort service in front of me. - I have a call recording of this incident, which I am attaching as evidence. - This left me mentally traumatized and deeply fearful for my life and that of my unborn child.

Incident on 22 February 2023 (Daughter was born): My daughter was born on 22 February 2023. My husband Mark Kujur did not visit the hospital to support or care for me. After several request he came to hospital he visited hospital and instead of taking care of me, he asked for RS 10,000 while I was lying in bed in the hospital and he took 10,000 from me, he fought with me, saying it was a girl and not a boy, and threatened divorce, stating he cannot not take care of me and the baby. This left me mentally shocked, depressed, and traumatized, as my husband showed no concern or compassion for me or our newborn.

Incident on September 2023: I was preparing breakfast for my father in law, after eating breakfast he throw the plate on my face and said na tujhe khana banana ata hai, tere gharwalo ne kuch bhi nahi sikhaya. - Mujhe ek activa scooter dila nahin to jaan se mardunga

Incident in October 2023: - After the birth of my daughter, my brother-in-law Birender Kujur told my husband to divorce me, saying I had no money and could not give them a male child. - My husband agreed with his brother's suggestion. - I was heartbroken and kept weeping the entire day, realizing the misery I was going through in their house.

2023-2024: During this time, I kept visiting my family home as I was kicked out of my marital home several times due to dowry demands

Incident in Feb 2024 - My father-in-law Peter Kujur forcibly kicked me out of the house, saying, "You cannot stay here, go and die." I left the house in fear and went to my mother's home, where I narrated the entire ordeal to her. Since then, I have been residing with my parents, mentally and physically distressed.

Incident on March 2024: - My husband, along with his parents and brother, physically assaulted me and threw me out of the matrimonial home, after which I have been residing at my parental home under severe mental and emotional stress.

3. Present Situation

Despite repeated attempts by my parents and elders to reconcile, my husband and in-laws have refused to take me back or return my Stridhan (jewellery, clothes, and gifts). They have also threatened me and my family if I lodge any complaint.

I continue to live in fear and suffer severe mental and emotional trauma due to their conduct and presently residing at Current Address: Newmal Railway colony Quarter no 35/A Malbazar at Badi Mumy house with my daughter with no income and way to maintain me and my daughter

4. Prayer

I therefore respectfully request you to: Take strict legal action against the accused persons as per law that is **Mr. Mark Kujur (husband, Government school teacher), Mr. Peter Kujur (father-in-law), Mrs. Florencia Kujur (mother-in-law), and Mr. Birender Kujur (brother-in-law)** and please conduct a fair, thorough, and impartial investigation

I am ready to cooperate fully with the investigation and provide all necessary evidence, witnesses, and supporting documents, including the attached call recording.
