I, Shri Kunal Dhar Sharma, s/o Mr Kanchik  
Dhar Sharma, resident of "Greetanjali  
Apartment, Nivedita Road, opposite - RRP  
Megamart, Pradhan Nagar, Siliguri beg

to inform you that on the year  
2022 and so on two persons, Anupam
