
Respected Sir,

This is to inform you that I, SRI DEBRAJ GHOSH, Son of Swaraj Ghosh, Resident of Hakimpara, Siliguri, P.O and P.S- Siliguri, Siliguri, District- Darjeeling, PIN- 734001, I am the proprietor of **ILA PLY AND TIMBER TRADERS**, having its office at 2ND Mile, Sevoke Road, Siliguri, District Darjeeling, West Bengal, Pin- 734001. That one **GOPAL INTERIORS**, Represented by its proprietor namely JHANTU MAHANTA, Having its office at 117/1385/92/E, Ektiashal, Siliguri, District- Darjeeling, West Bengal, PIN- 734006, approached my business for the requirement of plywood, veneered panels and others related articles from my business, that accordingly I agreed to supply materials to the said **GOPAL INTERIORS**. That upon supplying the material to the said **GOPAL INTERIORS**, the outstanding amount that is due on the part of the said **GOPAL INTERIORS** is Rs. 1,71,641/- (Rupees One Lakh Seventy One Thousand Six Hundred Forty One) only, which is still pending on the part of the said **GOPAL INTERIORS**. That I on behalf of my business on several occasions had asked the said **GOPAL INTERIORS** pay the said outstanding amount but the said **GOPAL INTERIORS** kept on delaying the same by giving several lame excuses. That whenever I on behalf of my business tried to reach to the said **GOPAL INTERIORS**, I have found nothing but vague replies and innumerable excuses and it is clear that the said **GOPAL INTERIORS** are intentionally avoiding the said due payment of Rs. 1,71,641/- (Rupees One Lakh Seventy One Thousand Six Hundred Forty One) only. That the said **GOPAL INTERIORS** has deliberately misappropriated the said amount of Rs. 1,71,641/- (Rupees One Lakh Seventy One Thousand Six Hundred Forty One) only for his illegal gains.


Hence it is clear from the atrocious acts the said **GOPAL INTERIORS** that they have committed a criminal breach of trust and fraud against my said business. Therefore, I pray before your goodself to kindly look into the abovementioned matter and take necessary actions against the abovementioned **GOPAL INTERIORS** as per the due course of Law for the administration of Justice.
