St. Biswajit Ghosh of Detective Department, Siliguri Police Commissioner Compression (Right) herewith following arrested accused persons viz., (1) Mahesh Sah @ Rajib (22yrs) S/o Late Umesh Sah of Vill & PO Debidanga (near Masjid) PS Pradhannagar Dist Darjeeling (2) Sujit Rangdar (30yrs) S/o Subhas Rangdar of Vill & PO Milanpally PS Bhorer ALo , Dist Jalpaiguri (3) Radheshyam Prasad (31yrs) S/o Manilal Prasad of Vill Ghoklajote, PO & PS Matigara, Dist Darjeeling (4) Dipak Kr Sah @ Munna (32yrs) S/o Sitaram Sah of Vill Ghoklajote PS Matigara Dist Darjeeling and (5) Rajib Chhetri (21yrs) S/o Ganesh Bahadur Chhetri of near Masjid, Debidanga, Ps Pradhannagar Dist Darjeeling along with seized articles as per seizure list, do hereby lodge a written complaint against the above noted arrested accused persons and others to the effect that today, ie. on 04/11/2025 at about 20.05 hrs received secret source information that one Radheshyam Prasad along with his associates is involved in preparation/manufacturing of forged Government Birth Certificate and other documents and supplying the same to interested persons in lieu of money for their wrongful gain and is at present coming to Champasari area from Matigara Bazar side. Accordingly, I diarised the information vide DD SPC, GDE No. 24 dated 04.11.2025 and inform the information to ACP, DD, SPC, Siliguri. As per order of ACP DD SPC, I along with SI Krishna Parja, ASI Sushanta Dey, Const-670 Ratan Roy and Const - 686 Arup Saha all of DD SPC left DD office at 20.15 hrs vide DD SPC GDE no 25 Dtd 04.11.2025 & MCC No. 288 dated 04.11.2025 to verify the veracity of the source information.

Accordingly Myself along with team reached at Asian Highway -2, Near Chandmoni Shiv mandir under Matigara PS at 20.25 hrs. On reaching there myself along with force and secret source waited for their arrival. At about 20.45 hrs on been shown by source from reasonable distance, we intercepted one two wheeler (Ola E-Scooty) bearing regd no.WB74BS- 6310 with pillion rider on it, near Chandmoni Shiv mandir, which was coming from Matigara side. On interrogation the rider disclosed his identity as Radheshyam Prasad (31yrs) S/o Manilal Prasad and Pillion rider as Dipak Kr Sah @ Munna (32yrs) S/o Sitaram Sah both of Vill Ghoklajote, PO & PS Matigara, Dist Darjeeling. On further interrogation regarding their movement/journey, they gave incoherent statements, which raised our doubts. Accordingly we cordoned them and started to search the seat dicky of said E-Scooty. During search found 05(five) nos of colour printed birth certificate issued in name of different persons, which seems to be forged. On questioning them regarding the possession of the said documents they could not give any satisfactory reply and stated that the said birth certificates are forged documents and they were carrying the same to deliver it to their other associates for delivering the same to the parties in lieu of money for their wrongful gain. Accordingly, I then seized the recovered forged documents, 02 (two) mobile phone i.e (1) Realme Note-12 5G mobile phone having IMEI No. 867353067300710/01 & 89918710400815493705 having huge number of images of fake birth certificates and other documents and (2)One Vivo T4X 5G mobile phone with IMEI No. 862971070831994 & 862971070831986 containing huge number of images of fake birth certificates along with one Ola E-Scooty bearing regd no.WB74B5-6310 from their possession under proper seizure list in between 21.05 hrs to 21.30 hrs. I then arrested them issuing necessary memo of arrest after observing all formalities. The entire process of seizure has been videographed. On interrogation they stated that they will lead the police party to arrest the other associates and to recover more forged

Accordingly as per their leading statement, myself along with force and the two arrested accused persons left for Champasari more under Pradhannagar PS at about 21.45 hrs. We reached near Army Transit Camp , Champasari More at about 21.55 hrs and as indicated by the arrested accused persons we EPAR cepted one Hyundai Santro four wheeler vehicle bearing No. WB 74 BE 3630 along with three containts inside the said vehicle. The arrested accused persons confirmed their identity as co – associates ho delinvolved in the commission of crime. Accordingly on interrogation they disclosed their identity as Makesh Shah @ Rajib (22yrs) S/o Late Umesh Shah of Vill & PO Debidanga (near Masjid) PS Fragitannagar Dist Darjeeling (2) Sujit Rangdar (30yrs) S/o Subhas Rangdar of Vill & PO Milanpally PS Bhorer ALo, Dist Jalpaiguri and (3) Rajib Chetri (21yrs) S/o Ganesh Bahadur Chetri of near Masjid, Debidanga, Ps Pradhannagar Dist Darjeeling. Then we conducted search inside the said vehicle and found 06(six) nos of forged colour printed birth certificate issued in name of different persons, which was kept concealed inside the Glove box of the said vehicle. On questioning them regarding the possession of the said documents they also could not give any satisfactory reply and stated that the said birth certificates are forged documents and they were carrying the same fir delivery to the parties in lieu of money for their wrongful gain. Accordingly, I then seized the recovered forged documents, 03 three mobile phone i.e (1) One Samsung Mobile phone model Galaxy S23 Ultra having IMEI No. 353835883202725 & 353901653202723 containing huge number of images of fake birth certificates and other documents (2)One POCO mobile phone having IMEI No. 861979071505682 & 861979071505690 containing huge number of images of fake birth certificates and other documents (3) One OPPO nibile phone having IMEI No. 863903054611018 & 863903054611000 along with one Hyundai Santro four wheeler vehicle bearing No. WB 74 BE 3630 from their possession under proper seizure list in between 22.05 hrs to 22.35 hrs. I then arrested them issuing necessary memo of arrest after observing all formalities. The entire process of seizure has been videographed.

From the above circumstances it is well evident that they prepared / manufactured forged documents knowingly to be forged with an intention to use it as genuine Government Document in lieu of money for their wrongful gain with the help of other associates. The grounds of arrest were issued and explained to all the above noted five arrested accused persons.

I therefore, request you that a specific case may kindly be started against the arrested person namely (1) Mahesh Sah @ Rajib (22yrs) S/o Late Umesh Sah of Vill & PO Debidanga (near Masjid) PS Pradhannagar Dist Darjeeling (2) Sujit Rangdar (30yrs) S/o Subhas Rangdar of Vill & PO Milanpally PS Bhorer ALo , Dist Jalpaiguri (3) Radheshyam Prasad (31yrs) S/o Manilal Prasad of Vill Ghoklajote, PO & PS Matigara, Dist Darjeeling (4) Dipak Kr Sah @ Mlunna (32yrs) S/o Sitaram Sah of Vill Ghoklajote PS Matigara Dist Darjeeling and (5) Rajib Chhetri (21yrs) S/o Ganesh Bahadur Chhetri of near Masjid, Debidanga, Ps Pradhannagar Dist Darjeeling and others under proper section of law.
