## **Details of the Incident**

- 1. Date and Time of Incident: 05/11/2025 at approximately 9:30 PM.
- 2. Place of Incident: Near my residence at Dakhin Palash, Naya Bazaar.
- 3. Accused Persons:
- Pollock Roy, S/o not known, Resident of Dakhin Palash, Naya Bazaar (My neighbour).
- Pritam Roy, S/o Pollock Roy, Resident of Dakhin Palash, Naya Bazaar (My neighbour).
- Certain friends of Pullock Roy approx 3 other people

## Respected Sir/Madam,

I, Tanu Sah Sharma, wife of Pintu Sah, permanently residing at Dakhin Palash, Naya Bazaar, P.O. Champasari, P.S. Pradhan Nagar, District Darjeeling, West Bengal, wish to report a serious incident of assault with intention to kill my husband, theft, molestation, and subsequent threats that occurred today and against the persons mentioned above.

That today around 9:30 PM, the accused, **Pollock Roy**, who is my neighbour, came to my house area in an allegedly **drunken condition**. He started a heated argument and began to **verbally abuse** my husband, **Pintu Sah** (S/o Late Sunil Saha), over some trivial matter. Suddenly, **Pritam Roy** (Pollock Roy's son) along with other people arrived at the spot in an aggressive manner. They all furiously started to **mercilessly assault** my husband, Pintu Sah, using **stones** and **bricks**.

When I heard my husband's cries, I rushed out to save him, the accused persons also turned on me. They started assaulting me and, in a shocking act, inappropriately touched me with the intent to outrage my modesty. Furthermore, they forcefully and violently snatched my golden earrings, one golden chain, and my gold mangalsutra before leaving the scene.

My husband was left lying there in a severely injured condition. I immediately took him to the hospital, and he is currently in a serious condition and undergoing necessary medical treatment. This person has followed me to the hospital and have threatened me. They explicitly warned me not to file any

complaint with the Police. They stated that if I proceed with this complaint, they would make the lives of myself, my husband, and my mother-in-law miserable and would take steps to force us to leave the village. These threats have caused severe fear and mental trauma to my family.

I request you to kindly register an First Information Report (FIR) immediately against Pollock Roy, Pritam Roy, and their friends under the relevant sections of the Law. I urge you to investigate the matter promptly, take necessary legal action to ensure our safety, and prosecute the offenders. A medical certificate for my husband is being attached and further medical records will be submitted as soon as possible.
