I, **Sri. Nripen Sutradhar**, son of Late Nimai Chandra Sutradhar, resident of East Chayanpara, Near Amtala Kadamtala Pipeline, Dabgram (2), P.O. Ghogamali, P.S. Bhaktinagar, District- Jalpaiguri, Pin- 734006, would wish to lodge this instant F.I.R. in respect of:

That I and **Sri. Nirmal Chakraborty**, son of Late Ramen Chakraborty, resident of Pritilata Sarani, Haiderpara, Ward No. 39 of SMC, P.O. Haiderpara, P.S. Bhaktinagar, District- Jalpaiguri, Pin- 734006, have filed a Title Suit vide Suit No. 11/2024 on 06/01/2024 before the Ld. Civil Judge Junior Division (1st Court) at Jalpaiguri in relating to land measuring 2.14 Kathas, in part of R.S. Plot No. 6 corresponding to L.R. Plot No. 98, recorded in R.S. Khatian No. 601 corresponding to L.R. Khatian Nos. 929, 930, Mouza- Dabgram, R.S. Sheet No. 11 corresponding to L.R. Sheet No. 74, Pargana- Baikunthapur, situated at Meghlal Roy Road, Shivrampally, Ward No. 39 of SMC, Police Station- Bhaktinagar, District- jalpaiguri, against 1. **SRI GOUR KUNDU**, Son of Sashti Kundu, resident of Surya Sen Colony, Block-D, P.O. Bhaktinagar, P.S. New Jalpaiguri, District Jalpaiguri, West Bengal, PIN: 734007 & 2. **SRI SABUJ KANTI DAS**, Son of Late Milan Kanti Das, resident of Nazrul Sarani, Purba Vivekananda Pally, Ward No. 39 of SMC, P.O. Rabindra Sarani, P.S. Bhaktinagar, District Jalpaiguri, West Bengal, PIN: 734006.

That as per the order No. 11 dated 22/05/2025, the Hon'ble court has directed that:

"The parties shall maintain status quo as regards the title, possession and their respective possession over the suit property".

The aforesaid defendants also filed an appeal before the Ld. District Judge, Jalpaiguri, vide Miscellaneous Appeal No. 17/2025, to quash the status quo order from the suit property, but the Ld. District Judge clearly ordered that to maintain the status quo so far the nature, character and possession over the suit property as to be followed by the parties to the suit/appellants.

But, on yesterday i.e. on 14/11/2025, while passing by the suited property, I have noticed, a boundary wall has been started to build there by the abovename defendants which is absolutely against the directions to be maintained given by the Learned Court.

So, therefore, It is my humble request to you to take necessary actions the abovenamed wrongdoers who are violating the Court Order in such a careless manner, and ensure that the status quo order of the Ld. Court shall be maintained peacefully until the further order.
