Respected Sir/Madam,

I, Shiv Kumar Prasad, proprietor of Disha Hardware Store, located at Prakash Nagar, Siliguri - 734001, dealing in the Business of Hardware Items such as Paints, Primers, Thinners, Tinters, Hardeners etc.

However, I do hereby lodge a formal complaint regarding a theft incident that occurred at our godown premises located at Gandhi Nagar, Siliguri - 734001.

On 29/11/2025, at approximately 9:00 AM, during our routine visit to the godown premises, we discovered that unknown miscreant(s) had broken into the godown during the midnight hours by forcibly breaking and opening the lock on the main gate. Upon further inspection of the premises, it was found that several items, including paints, tinters, thinners, and other related goods, had been stolen.
