Sir,

With due respect and humble submission I, ASI Rabin Lama of Siliguri PS under Siliguri Police Commissionerate do hereby lodged this written complaint against one lady namely Monika Das-32yrs w/o Ashim Das of Durgadas colony, ward no-20 PS Siliguri Dist Darjeeling to the effect that on 17.02.26 at 09.15 received a source information from Subhashpally, Wqard No-18 under Siliguri PS that one lady named Monika Das-32yrs w/o Ashim Das of Durgadas colony, ward no-20 PS Siliguri Dist Darjeeling was standing at Subhashpally beside FCI Godown Bagrakote with huge quantity of liquor in her possession for selling the same in the open market for her wrongful gain without any documents/license. Diarized the fact in GDE vide Siliguri PS GDE No- 840 dated 17.02.26. As per your kind instruction immediately myself along with SI Srimanta Chatterjee, ASI Debasish Das, ASI Minhaj AL Kader, and L/C 1295 Swastika Rai, LC/186 Anisha Biswakarma all of Siliguri police station proceeded to the PO to work out the information. Within 20 minutes we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered and seized the following articles from her possession:- (1) 18 (Eighteen) bottles of Himalayan Gold 60(Sixty) of country spirit each bottle containing 600ml. Each bottle Rs 160/-(One Hundred Sixty) total value of Rs 160x18= 2880/- each which is containing paper cartoon box.

During local enquiry it came to learn that the name of alleged lady is selling the same in open market since long for her wrongful gain without any valid documents/license. In presence of witnesses namely:-



I seized the above noted articles from the PO (The seizure was made in between 10.09 hrs to 10.35hrs) after preparing proper seizure list duly signed by them. The whole search and seizure process was conducted under proper audio video record.


I therefore request you a specific case may kindly be started against the accused lady namely Monika Das-32yrs w/o Ashim Das of Durgadas colony, ward no-20 PS Siliguri Dist Darjeeling under

proper section of law and arrange for investigation.
