Sir,

In producing herewith 04 (four) arrested accused persons namely (i) Bajrangi Kumar Sah (25) S/O Rajendra Sah of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri, (ii) Tuntun Roy (24) S/O Chandra Sekhar Roy of Maharaj Colony, Ward No. 5 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iii) Chhotu Sahani (25) S/O Shambhu Sahani of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri, (iv) Abhi Sahani (21) S/O Rajesh Sahani of Prakashnagar, Saqhani Busty Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri. The ground of arrest has been communicated with them.

I, ASI Sanjay Sarkar of Khalpara TOP under Siliguri PS, SPC do here by lodged a written complaint against the above noted accused persons and others to the effect that on 04.03.2026 at 00.05 hrs. during my night van duty, I received a source information that 5/6 youth had assembled at Santoshinagar more under Siliguri PS and they were creating public nuisance at that area. Subsequently, after sharing the information with my superiors and as per their direction, at 00.15 hrs myself along with force of Khalpara TOP left for the place to work out the information. By Govt. Vehicle vide Khalpara TOP GDE No- 76 Dated- 04.03.2026.

Thereafter, myself along with forces reached at Santoshinagar more under Siliguri P.S at 00.10 hrs. and found that the above noted accused persons were gathered at Santoshinagar more and raising slogans in filthy languages and also block free flow of traffic movements and also created public nuisance.

Therefore, I along with other police personnel tried to remove them from the spot and tried to control over the situation to avoid any adverse situation in the occasion of 'Holi'. But seeing the police personnel they became aggravated and intentionally raising slogans in filthy languages. In spite of cooperation and obeying lawful direction of on duty police personnel, they become aggravated and also abstract on duty police personnel in the discharge of our public duty and they also use criminal force to us.

Hence, finding no other alternatives, I arrested above noted accused persons named (i) Bajrangi Kumar Sah (25), S/O Rajendra Sah of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri, (ii) Tuntun Roy (24) S/O Chandra Sekhar Roy of Maharaj Colony, Ward No. 5 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iii) Chhotu Sahani (25) S/O Shambhu Sahani of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri, (iv) Abhi Sahani (21) S/O Rajesh Sahani of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri after issuing Memo of Arrest. The ground of arrest has been communicated with them.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons namely (i) Bajrangi Kumar Sah (25) S/O Rajendra Sah of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri, (ii) Tuntun Roy (24) S/O Chandra Sekhar Roy of Maharaj Colony, Ward No. 5 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iii) Chhotu Sahani (25) S/O Shambhu Sahani of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri, (iv) Abhi Sahani (21) S/O Rajesh Sahani of Prakashnagar, Saqhani Busty, Ward No. 43 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri and others and arrange for its investigation.
