Sir,

In producing herewith four (04) arrested accused persons, namely (i) Ajoy Mahanta (26 yrs) s/o Lt. Dulal Mahanta of Netaji Pally Rabindra Sarani, PO- Goghomali, ward no.-37, PS- Bhaktinagar, dist- Jalpaiguri (ii) Dhaneshwar Roy @ Karna (28) s/o Karthik Roy of Bholanathpara, PO- Ghogomali, PS- Bhaktinagar, dist- Jalpaiguri (iii) Bishnu Kamti (23) s/o Mantu Kamti of Khudiram Colony, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri and (iv) Mintu Roy (28) s/o Sudhir Chandra Roy of Adarshapally near Eskon Mandir PO- Sahudangihat, PS- Bhaktinagar, dist- Jalpaiguri arrested u/s- 35 BNSS along with following seized articles viz:

- (1) One iron-made rod measuring 2 feet (approx.) was found from the exclusive possession of Ajoy Mahanta, which was kept in back.
- (2) One iron-made crowbar measuring 2 feet (approx.) was found from the exclusive possession of Dhaneshwar Roy @ Karna, which was kept in his right hand.
- (3) One charger light red and black in colour styled as A AKARI-111TU was found from the possession of Bishnu Kamti which was kept in his left hand.
- (4) One iron made machete measuring 2 feet in length (approx.) was found from the possession of Mintu Roy which was kept in his left hand.

I, ASI Madhusudan Barman, S/O- Tarunikanta Barman of Ashighar OP under Bhaktinagar Police Station, Siliguri Police Commissionerate, do hereby lodge this complaint against the above-noted accused persons, namely (i) Ajoy Mahanta, (ii) Dhaneshwar Roy @ Karna (iii) Bishnu Kamti and (iv) Mintu Roy and others to the effect that today on 24/03/2026 at 00:25 hrs while performing night patrolling duty received a source information that 12/14 youths have assembled near Hatiadanga School Ground under Bhaktinagar PS with a view to commit dacoity in a house at Hatiadanga area under Bhaktinagar Police Station. Accordingly, the fact was diarised in GD vide Ashighar OP GDE No- 864 dated 24/03/2026. Subsequently, after sharing the information with my superior and as per his direction, I, along with ASI, Dinesh Chandra Roy, ASI- Pramod Tamang, C/970 Bikash Roy, C/1547 Prabir Das, C/376 Shyamol Chowdhury and CV/909 Nityananda Chowdhury, all of Ashighar Out Post, left for Hatiadanga School Ground to verify the veracity of the source information. At about 00:50 hrs after reaching near Hatiadanga School Ground, I met my source and, being pointed by the source, we started walking towards Hatiadanga School ground. At around 01:15 hours, we reached at Hatiadanga School Ground and began to cordon off the suspected individuals being identified by my source. We had a strong reason to believe that they were preparing to commit a cognizable offence and were about to leave the area. However, upon noticing the police approaching, they attempted to flee. After a hot chase, we successfully apprehended ~~four~~ accused individuals along with the seized articles mentioned above. Unfortunately, a number of others managed to escape from the spot, taking advantage of the darkness.

During the interrogation, the apprehended individuals admitted that they had gathered there with other associates with a view to commit dacoity at a house in Hatiadanga area under the Bhaktinagar police station.

Following that I, seized the above-noted weapons from their possession under the proper seizure list and videography, duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made between 01:45 hrs to 01:54 hrs. Thereafter, I arrested the above-noted accused persons u/s 35 BNSS under a proper memo of arrests duly signed by the accused persons and also supplied a copy of the memo of arrest to them.

Subsequently, I brought the arrested accused persons along with the seized articles to Bhaktinagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they had gathered there to commit dacoity in a house in Bholanathpara area under Bhaktinagar PS.

Hence, under the above noted facts and circumstances a specific case may kindly be started under proper section of law against the above noted arrested accused persons namely (i) Ajoy Mahanta (26 yrs) s/o Lt. Dulal Mahanta of Netaji Pally Rabindra Sarani, PO-Goghomali, ward no.-37, PS- Bhaktinagar, dist- Jalpaiguri (ii) Dhaneshwar Roy @ Karna (28) s/o Karthik Roy of Bholanathpara, PO- Ghogomali, PS- Bhaktinagar, dist- Jalpaiguri (iii) Bishnu Kamti (23) s/o Mantu Kamti of Khudiram Colony, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri and (iv) Mintu Roy (28) s/o Sudhir Chandra Roy of Adarshapally near Eskon Mandir PO- Sahudangihat, PS- Bhaktinagar, dist- Jalpaiguri and others and arrange for its investigation.
