I Tukhuki Khater, w/o
Shekh Imadadulla Faruque, resident of
Ashraf Nagar, Ward NO. 40 SMC, P.S.
Bhaktinagar, Dist.: Jalpaiguri beg to
state as follows:

- ① That one ^① Adia Begam @ Arjia Begam
w/o Manu Haque, ^② Manu Haque, ^{Khater}
^③ Moni Haque, ^④ Jhumpa Haque, and
Nilima, ^{Khater} all the three are son and
daughters of Adia Begam and
Manu Haque attacked me and my
minor daughter today i.e. 2/4/26
at around 11:00pm when I went
to visit my registered gift-deed
land at Budda Masjid head,
Gital Para, Ashraf Nagar, P.S. Bhaktinagar
Dist. Jalpaiguri and found that
the said Adia Begam along with

her husband Manee Haque, son
Meri Haque and two daughters
namely Thunpa khalee and
Nilima khalee was making
illegal construction in my
registered land.

② That when I objected these such
illegal act they all attacked me
with fists and blows and kicks
and the said Manee Haque and
Meri Haque caught hold of my
hair toke and started molesting
me with the intention of
outraging my modesty. Also the
father and son tore upon my
kurtā exposing my private parts.
disrobing me and exposing my
body.

③ That thereafter Thunpa khalee
and Nilima khalee tried to
strangulate me with my dupatta
with the intention of killing me
on spot, because of such
strangulation I fell on the
ground and hurt myself.

(4) Seeing this I raised hue and
cries. Hearing my hue and
cries few of the nearby people
came to save me and seeing them
come, all of them ran away
from the spot and also warned
me of dire consequences if I
again came to the land and
objected their such illegal act.

I therefore request you to
kindly take strict action against
the aforesaid culprits.
