The accused persons namely i) **Md. Jahangir (35/M) s/o Md. Jafir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling** and ii) **Sabbo Begum (28/F) WO- Md. Jahangir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling** are hereby produced before you along with the following seized articles under seizure as per seizure list which have been duly marked and sealed as follows:

- 1) One white colour plastic packet with zipper seal said to be brown sugar containing 300 grams approx wrapped in black colour polythene marked as "Exhibit A"
- 2) One light blue Vivo V27 brand android mobile phone having IMEI No- 869657068537072/64 along with SIM having no- 9046929963 marked as "Exhibit B"
- 3) One TVS scooty bearing Registration No- WB 73 K 5650 (Colour- Maroon) along with key marked as "Exhibit C"
- 4) Cash Rs 1400/- (Fourteen Hundred only) in Indian currency in denomination of (Rs 100 x 14) =Rs 1400.

I, Sub-Inspector Binup Mahato of New Jalpaiguri Police Station under Siliguri Police Commissionerate, do hereby lodge this written complaint against the above-noted arrested accused persons namely i) Md. Jahangir (35/M) s/o Md. Jafir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling and ii) Sabbo Begum (28/F) WO- Md. Jahangir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling to the following effect: That on 27.04.2026 at about 22:10 hours, I have received specific and credible information indicating that two individuals are traveling from Kishanganj towards Siliguri using a scooty bearing registration number WB 73 K 5650 carrying a substantial quantity of a narcotic substance, commonly referred to as "brown sugar," with the intention of delivering the same to designated recipients. That the said information was immediately recorded in the General Diary vide NJP PS GDE No. 1449 dated 27.04.2026 and the matter were duly intimated to you. Acting upon your direction, I, SI Binup Mahato, SI Tanmoy Kundu, ASI Khagen Barman, LC/746 Atoshi Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, all attached to NJP Police Station under Siliguri Police Commissionerate, proceeded to the said place of occurrence by Government vehicle, carrying the investigation kit, to verify the veracity of the information, vide NJP PS GDE No. 1450 dated 27.04.2026 vide MCC No- 1002/26 Dated 27/04/2026. That under the prevailing circumstances, it was not practicable to obtain a search warrant or prior authorization without affording sufficient opportunity for the concealment of evidence or for the escape of the offenders, and hence immediate action was necessitated.

That, while proceeding towards Biswa Bangla Shilpi Hat, I secured the two independent witnesses, namely (1) Kartik Mandal (44), son of Lt. Falguni Mandal, resident of Porajhar, Satellite Township, PS-NJP, District-Jalpaiguri, and (2) Joy Kr. Biswas (27) son of Kamal Biswas, resident of Sushratnagar, Bidhanpally, PS- Matigara, Dist- Darjeeling and the videographer namely Tapan Mondal S/O- Tushta Mondal of Suryasen Colony, Block E, PS- NJP, Dist- Jalpaiguri. Both the said independent persons were duly apprised of the information in hand and were requested to act as independent witnesses in the event of any search and seizure, to which they willingly consented. That thereafter, I, along with the accompanying police personnel and the aforesaid independent witnesses, reached in front of Biswa Bangla Shilpi Hat at about 22:35 hours. After waiting for the duration as indicated by the source, we intercepted one scooty bearing registration No. WB-73 K-5650, on which two persons were found travelling. Upon such interception, we duly disclosed our identity and official capacity to the said persons and apprised them of the specific information so received. They were further informed that, in connection with the said information, it was necessary to conduct a search of their persons as well as of the aforesaid scooty. On being questioned, the said persons disclosed their identity as noted above and admitted that they are in unlawful possession of Brown Sugar in the scooty, intended for sale to their prospective customers as per demand. That thereafter, a written notice was duly served upon the said persons, informing them of their legal right to be searched in the presence of an Executive Magistrate or a Gazetted Officer. The said person, having understood the contents of the notice, expressed his willingness to be searched in the presence of either of the aforesaid authorities. That accordingly, the matter was immediately communicated to Shri Ranjan Das, Inspector-in-Charge, NJP Police Station, Siliguri Police Commissionerate, and as per his instruction I communicated to Shri Ahitangi Chakraborty, ACP EAST II, SPC who was detailed to act as Special Executive Magistrate for the day, was duly informed regarding the interception of the accused persons and scooty bearing no WB 73 K 5650 suspected to be in possession of Brown Sugar and was requested to kindly proceed to Infront of Biswa Bangla Shilpi Hat under PS-NJP, District-Jalpaiguri to remain present and to supervise the search and seizure proceedings.

Accordingly, at around 23.10 hrs Shri Ahitangi Chakraborty, ACP EAST II, SPC, detailed for acting as Special Executive Magistrate, of SPC for the day arrived at the spot at infront of Biswa Bangla Shilpi Hat under NJP PS as Special Executive Magistrate, SPC. Then I offered the independent witnesses and the accused persons to search our police party as per provision of law but they did not search the police party. After that in presence Shri Ahitangi Chakraborty, ACP EAST II, SPC detailed for acting as Special Executive Magistrate, of SPC for the day and 02 (two) independent witnesses, I with the help of LC/746 Atoshi Roy searched the detained persons who disclosed his identity as i) Md. Jahangir (35) s/o Md. Jafir of Jhankar More, Koila Deppo, PS-Siliguri, Dist- Darjeeling and ii) Sabbo Begum (28/F) WO- Md. Jahangir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling and scooty bearing no WB 73 K 5650 following all formalities, keeping their decency and recovered the above noted 1) One white colour plastic packet with zipper seal said to be brown sugar containing 300 grams approx wrapped in black colour polythene mark as "Exhibit A" 2) One light blue Vivo V27 brand android mobile phone having IMEI No- 869657068537072/64 along with SIM having no- 9046929963 mark as "Exhibit B" 3) One TVS scooty bearing Registration No- WB 73 K 5650 (Colour- Maroon) along with key 4) Cash Rs 1400/- (Fourteen Hundred only) in Indian currency in denomination of (Rs 100 x 14)=Rs 1400. from the exclusive and conscious possession of above noted accused person.

Further, on demand in presence of Shri Ahitangi Chakraborty, ACP EAST II, SPC detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses the above noted detained persons failed to produce any valid documents in support of possessing of Brown Sugar found from his possession.


Thereafter, I weighted recovered one white colour plastic packet with zipper seal said to be brown sugar in presence of Shri Ahitangi Chakraborty, ACP EAST II, SPC detailed for acting as Special Executive Magistrate, of SPC for the day and the independent witnesses with the weighing instrument and found total 300 (Three Hundred) grams of Brown Sugar in which were kept inside black colour polythene carrying by accused persons namely i) Md. Jahangir (35) s/o Md. Jafir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling and ii) Sabbo Begum (28/F) WO- Md. Jahangir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling and marked as Exhibit "A". Accordingly, I seized the above-noted articles from the exclusive possession of the above noted accused persons at the spot i.e. In front of Biswa Bangla Shilpi Hat, under PS NJP, District - Jalpaiguri, as per the attached seizure list. The seizure and labeled was conducted in the presence of Shri Ahitangi Chakraborty, ACP EAST II, SPC, detailed to act as Special Executive Magistrate of SPC for the day, as well as the independent witnesses mentioned above. Subsequently, the entire seizure process took place between 23:25 hrs and 23:45 hrs on 27/04/2026.

During the course of further interrogation, the accused persons hereinabove named, in the presence of Shri Ahitangi Chakraborty, ACP EAST II, SPC, who was duly detailed to function as Special Executive Magistrate for the day, and in the presence of independent witnesses, voluntarily and without any coercion admitted that they had clandestinely procured the aforesaid contraband substance, namely Brown Sugar, from the Kishanganj region with the intention of selling the same to selected customers at an enhanced price for wrongful gain through illegal means at Siliguri area. The accused person further disclosed that they had been continuously engaged in such illegal procurement and sale of Brown Sugar for the past several years for the purpose of deriving unlawful gain. Thereafter, at about 23:50 hours, I placed the aforesaid accused persons under arrest after duly complying with all statutory formalities, including informing him of the grounds of arrest, and thereafter issued the requisite Memo of Arrest in accordance with law.

In view of the facts and circumstances stated hereinabove, it is most respectfully prayed that yourself to register a case against the arrested accused person namely i) **Md. Jahangir (35) s/o Md. Jafir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling** and ii) **Sabbo Begum (28/F) WO- Md. Jahangir of Jhankar More, Koila Deppo, PS- Siliguri, Dist- Darjeeling** under the appropriate provisions of law, and to cause a fair, impartial, and expeditious investigation into the matter in accordance with law.
