Subject Complaint regarding brutal assault, criminal intimidation, abusive and derogatory remarks, and attempt to kill.

Sir,

I, Shivam Kumar Singh, son of Shib Chandar Singh, resident of Kanta Lal Road, Ektiasal, Ward No. 40, Siliguri (M. Corp), P.O. Sevoke Road, District Jalpaiguri, West Bengal – 734001, most respectfully beg to state as follows

That on 10052026 at around 1000 PM, I had gone to purchase medicine from Anchal More, Isckon Mandir Road. While returning home at about 10:15 PM and when I reached near Sri Sri Vatika Apartment, I was riding my scooty when suddenly a minor accident took place between my scooty and another scooty bearing registration no. WB74BH4623, on which three persons were travelling.

Thereafter, I immediately conveyed my apology to them for the minor incident. However, all the said persons suddenly became aggressive and started brutally assaulting me mercilessly with hands, punches, fist blows and by using a hard objectbala. They continuously assaulted me in a ruthless manner despite my repeated requests and begging for mercy.

During the course of assault, the accused persons intentionally abused and humiliated me in filthy and derogatory language targeting my regional identity and political affiliation by stating in Bengali words to the effect

“Tora BJP kei vote dichis, Amra didir bhakto ki baal chirbi re Tora , bhag ekhon theke.”

By such utterances, the accused persons intentionally insulted, threatened and humiliated me in public while continuing the physical assault.

Thereafter, the accused persons forced me to call my father and asked me to bring him to the spot. When my father could not immediately receive the call, the accused persons became more violent and again started assaulting me with the intention to kill me. They repeatedly struck me on my face, throat and other parts of my body, causing severe injuries. Due to the brutal assault, my teeth were damaged, I sustained injuries on my throat and chest area and I almost became unconscious and fell on the road.

Taking advantage of my condition, the accused persons took my gold chain and fled away from the place of occurrence. Thereafter, my father and brothers arrived at the spot and immediately shifted me to the hospital for medical treatment.

The names of the accused persons are as follows

1. Bikram Roy, son of Subhash Roy;
2. Hiday Roy, son of Jharu Mohan Roy;
3. Narayan Gupta

All the accused persons were travelling on scooty bearing registration no. WB74BH4623.

I therefore request you to kindly treat this complaint as an FIR, initiate immediate investigation, take strict legal action against the accused persons and provide me necessary protection and justice and do the needful.

I shall remain ever grateful.
