Whereas for smooth passage for the public during the visit of Hon'ble Chief Minister of West Bengal on 10.09.2025 at Siliguri Police Commissionerate area, it is necessary in the interest of Public safety and also to prevent danger, obstruction, inconvenience to public in general during the visit of Hon'ble of Chief Minister of West Bengal, to impose traffic restriction for regulating the movement of vehicles at different parts of Siliguri Police Commissionerate area during the period.

In exercise of power conferred upon me U/S 115,116,117 of the Motor Vehicles Act, 1988 (59 of 88) read with Notification No. 4595-WT/3M-80/2002 dated 28.12.2012 of Transport Department, Government of West Bengal, I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate do hereby issue following restrictive orders as per following time schedule on the following roads.

1. The restrictions/ holding points of heavy goods and medium goods vehicles and the timings of such restrictions/holdings will be as under :

Sl. No.	Places of Restriction	Time of Restriction (Column "A")
1.	Fulbari Bypass More	0800 hrs to 2100 hrs
2.	Bhaktinagar Checkpost	0800 hrs to 2100 hrs
3.	IOC/ Netaji More	0800 hrs to 2100 hrs

Date & Time of Restriction

➤ On 10.09.2025 from 08:00 hrs. to 21:00 hrs.

[A] RESTRICTIONS OF ROADS FOR GOODS VEHICLES/ HEAVY GOODS VEHICLES/ MEDIUM GOODS VEHICLES :

- 1) No goods vehicles shall be allowed from Naukagat More towards Jalpaiguri side.
- 2) No goods vehicles shall be allowed from Hati More to Ambari Bazar.
- 3) No goods vehicles shall be allowed from Regulated Market to Naukaghat side and Bhaktinagar Checkpost side.

[B] DIVERSION POINTS: :

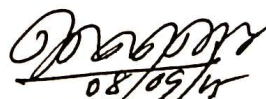
- 1) TRUCKS COMING FROM GANGTOK AND KALIMPONG / DOOARS SIDE PLYING TOWARDS GHOSHPUKUR SIDE WILL BE DIVERTED THROUGH – DARJEELING MORE – PARIVHAN NAGAR – BIHAR MORE NH -31(10).
- 2) TRUCKS COMING FROM JALPAIGURI SIDE TOWARDS RAIGANJ SIDE WILL BE DIVERTED THROUGH FULBARI- MD BOX MORE- GHOSH PUKUR.
- 3) TRUCK DEPARTURE FROM SILIGURI TOWN TOWARDS GHOSHPUKUR SIDE WILL BE DIVERTED THOUGH NAUKAGHAT- UNDER BYPASS TOWARD BIHAR MORE.

Exemptions:

- (i) Goods vehicles with perishable goods and milk.
- (ii) Goods vehicles loaded with LPG cylinders.
- (iii) Army goods vehicle/trucks.
- (iv) Ambulance etc.

NOTE: THE TIMING OF RESTRICTION COULD BE CHANGED CONSIDERING THE CROWD SITUATION IN THE TOWN ON SHORT NOTICE.

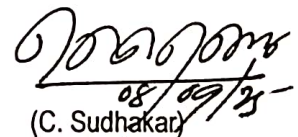

5	Sukna TCP More	0800 hrs to 2100 hrs

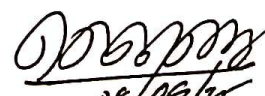
Beyond the restriction of these timings, heavy and medium goods vehicle can ply on the roads under the area of Siliguri Police Commissionerate. During the timings mentioned under the Column "A" of the above, no such heavy goods and medium goods vehicle shall ply over the following stretch of road:

Sl. No.	Restricted Roads for Heavy & Medium Goods Vehicles
1	From Parivahan Nagar More towards Darjeeling More on all roads upto Bhaktinagar Checkpost and Naukaghat.
2	From Fulbari Bypass Road towards Naukaghat
3	(i) From Bhaktinagar Checkpost towards Airview More, Sevoke Road, Bidhan Road and Hill Cart Road. (ii) From Bhaktinagar Checkpost towards Sahid Nagar More upto Parivahan Nagar via Darjeeling More.
4	From IOC/ Netaji More towards Siliguri Town.
5	From Sukna TCP More to Darjeeling More on NH-55 Stretch.

Exemptions:

- (i) Goods vehicles with perishable goods and milk.
(ii) Goods vehicles loaded with LPG cylinders/fuel/lubricants.
(iii) Army goods vehicle/trucks.

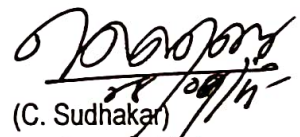
