

**ORDER**

Whereas, information has been received regarding the proposed visit of Ms. Mamata Banerjee, the Hon'ble Chief Minister of West- Bengal on 15.04.2026 under the jurisdiction of Siliguri Police Commissionerate. As per the directions and guidelines issued from Director Security, West Bengal vide Memo No. 1831(120)/ DS dated 06/04/2026 regarding Anti-Drone measures during VVIP/ VIP visit, this order is being issued.

And

Whereas, for security and ensuring a safe air passage for the Ms. Mamata Banerjee and safety of other dignitaries, it is decided in the ASL meeting held on 13/04/2026 that drone flying, hot air balloon and other such activities which can obstruct the air traffic, need to be stopped from 14th April 2026, 6:00 A.M. - 16th April 2026, 6:00 A.M. I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Notification No. 1548/1(8)-P.S. Cell/HR/O/3P-42/14 dated 16/08/2024 of Senior Deputy Secretary to the Govt. of West Bengal.

And

Now therefore, in exercise of the power conferred by Sub-section (1)(3) of Sec. 163 of the Bharatiya Nagarik Suraksha Sanhita of 2023, I, **Syed Waquar Raza, IPS** Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby order that **No drone, hot air balloons and other such activities which can obstruct the air traffic shall be flown in the below mentioned areas -**

(i) within a distance 05 (five) km from the periphery of Bagdogra Airport (Air Force Station) under Bagdogra PS, Siliguri Police Commissionerate.

(ii) within a distance of 05 (five) km from the Chandmani Cricket Ground (Helipad) under Matigara PS, Siliguri Police Commissionerate.


(iii) within a distance of 05 (five) km from the periphery of Siliguri Hindi High School ground (Helipad) under Siliguri Police Commissionerate.

(iv) within a distance of 05 (five) km from the periphery from Heritage Hotel More to Hasmi Chowk (Venus More) under Siliguri Police Commissionerate.

Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and order is passed ex-parte u/s 163(2) of BNSS of 2023.

This order will take into immediate effect and will remain in force till the completion of the proposed visit.
