NOTIFICATION

Whereas for smooth passage for the public during the "Durga Puja Carnival-2025" to be celebrated on 04.10.2025 under the jurisdiction of Siliguri Police Commissionerate, it is necessary in the interest of public safety and also to prevent danger, obstruction, inconvenience to public in general during the "Durga Puja Carnival-2025", to impose traffic restriction for regulating the movement of vehicles at different parts of Siliguri Police Commissionerate area during the period.

In exercise of power conferred upon me U/S -115 of the Motor Vehicles Act, 1988 (59 of 88) read with Notification No.4595-WT/3M-80/2002 dated 28.12.2012 of Transport Department, Government of West Bengal, I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate do hereby issue following restrictive orders as per following time schedule on the following roads.

Date & Time of Restriction

➤ On 04.10.2025 from 14.00 hrs to onwards.

[A] RESTRICTIONS / DIVERSIONS FOR ALL TYPE OF VEHICLE:

1. Nabin sen road & church road are only exit roads for the small vehicles coming from junction side. Both the points on hill cart road will not allow any vehicles to enter towards Air view more. All vehicles are diverted towards Gurdwara on Nabin sen road in order to restrict vehicle from plying towards Air view.
2. Buses plying from Siliguri to Jalpaiguri/Coochbehar/ Alipurduar/ Assam will be operated from Noukaghat.
3. All type of vehicles will not be allowed from Tikia Para, Thana more and Maha bir sthan towards venus more .
4. No goods vehicles and Buses will be allowed towards Air view more from Junction side.
5. All type of four wheelers coming from to Checkpost side to Panitanki more will be diverted through Iskon mandir road.
6. All type of vehicles coming from Nowkaghat towards Airview more will be diverted from Jhankar more via Thakar bridge towards Matgara side and in a same way no vehicles from Matigara side will be allowed to ply towards Jhankar more.

NOTE: THE TIMING OF RESTRICTION COULD BE CHANGED CONSIDERING THE CROWD SITUATION IN THE TOWN ON SHORT NOTICE.

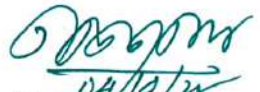
