- In exercise of power conferred upon me u/s- 144 (2) Cr.P.C. direct that 5(five) or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/premises/ around the venue of said examination; and
- Prohibit assembly of **five (5)** or more persons within the radius of **100 (one hundred)** meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- Prohibit plying of loud speaker, microphone etc in and around 200 (two hundred) meters of examination venues. Use of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and
- 4. I do hereby also prohibit entrance of any person except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till its completion; and

The following articles was found and seized-i) 1KG 376 Grams of Brown Sugar, ii) One Vehicle (Bolero Pickup) bearing Regd. No- WB 65 C 9327 and iii) Cash Rs-7,45,000/-. On 05.12.2022 Ld. Judge Special Court under NDPS Act called for a report from him regarding the release of the seized vehicle bearing regd. No- WB 65 C 9327. His such perfunctory investigation, gross negligence & dereliction of duty showed an aberration from the ethics of disciplined Police department and tantamount to infringement of Rule nos. 03 & 04 of West Bengal Govt. Servants' Conduct Rules, 1959.

While being attached to Khalpara TOP under Siliguri PC, he [ASI (UB) 968 Sanjay Hasda] was detailed to perform K-27 Mobile Van Duty on 08.04.2022 along with C/466 Tarun Pahan, CV-980 Ranjan Ojha and Civil Driver Bapi Roy vide Khalpara TOP GDE No- 199 dated-08.04.2022 and M.C.C No 986 Dated-08.04.22. On enquiry it was found that one Sewan Sharma of Pakyong, East Sikkim who belonged to poor family had got Government house scheme, where in order to save money he was on his way to Distributor for shopping household goods. While he was returning in the toto, the Police Van intercepted him then he was taken to one corner where he was threatened with legal consequences if he doesn't give money to the Police. Consequently, Sewan Sharma out of frighten and as per his direction transferred the amount of Rs-4000/- through online transaction on the account of Civil Driver Bapi Roy. Thus, his act of receiving illegal transaction of amount of Rs.4000/- as a bribe from an innocent citizen is unwarranted of police personnel.

His such moral turpitude and indiscipline conduct is detrimental to this disciplined Police department and tantamount to infringement of Rule Nos. 03 & 04 of West Bengal Government Servants' Conduct Rules, 1959.

The Charged ASI (UB) 968 Sanjay Hasda received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 04/08/2022. In his written reply dated 11/08/2022, he did not plead guilty to the charge drawn up against him and preferred an open enquiry. The Proceedings File No. 21/2022 dated-03/08/2022 was endorsed to the Shri Manabendu Sekhar Rakshit the then ACP EB, SPC for the enquiry and submission of findings at an early date. On completion of enquiry, Shri Manabendu Sekhar Rakshit the then ACP EB, SPC submitted his findings on 20.01.2023

The charge as drawn up against SI(UB) Uttam Kumar Baghira is summarized below:-

While being attached with Pradhan Nagar PS under Siliguri Police Commissionerate, he(SI(UB) Uttam Kumar Baghira) was endorsed to investigate Pradhan Nagar PS Case No. 740/18 dated 29/12/2018 U/S-363/365 IPC. On 13/01/2019 he recovered the VG and seized the Aadhar Card of VG in which identity of VG written as D/O Laxman Singh but surprisingly he wrote identity of unmarried VG as W/O Sintu Mahato (FIR named accused person). This means he considered the unmarried VG as wife of accused person. On 14/01/2019 the statement of VG was recorded U/S-164 Cr.P.C. and on 16/01/2019 he received the copy of statement wherein the VG stated that Sintu Mahato and his brother Ranjit raped her and all seven brother of accuseds are involved in the case. Hence he should have immediately applied for adding section 6 of POCSO Act or 376(2)(n) IPC, but he prayed for adding section 6 of POCSO Act after a delay of almost one month (28 days). On 28/03/2019 the principal accused Sintu Mahato was arrested and prayer for his potency test was given by him on 24/05/2019 & potency test done on 29/05/2019. He should have given prayer for potency test of accused on the next day of arrest to complete the investigation on time, but he gave it almost 2 months (58 days) after arrest of accused. He unnecessarily prolonged the investigation and as a result all important accused persons were granted bail. Despite of several verbal instruction of superior officer he did not seize the GDE No. 1083 of Pradhan Nagar PS dated 19/12/2018 which could have convinced the Ld. Court that when the offence was committed then the victim was minor and the case falls well within the jurisdiction of POCSO court. He has not submitted the correct Charge Sheet in the case despite of several reminders by his superior which is adversely affecting the delivery of justice. Moreover, this being a case involving offence of rape, as per order of Supreme Court investigation has to be completed within 60 days. During investigation of the said case he disobeyed lawful instructions of Shri Vidit Raj Bhundesh, IPS, ACP West, and SPC and did not make sincere efforts to complete the investigation within 60 days which is mandatory in Rape/POCSO Cases.

His such perfunctory investigation, gross negligence & dereliction of duty showed an aberration from the ethics of disciplined Police department.

The Charged SI (UB) Uttam Kumar Baghira received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 17/02/2020. In his written reply dated

21/02/2020, he did not plead guilty to the charge drawn up against him and preferred an open enquiry. The Proceedings File No. 04/2020 dated-17/02/2020 was endorsed to Smt. Moumita Karmakar the then ACP HQ, SPC for the enquiry and submission of findings at an early date. On her transfer to Islampur P.D the file was re-endorsed to Shri Debasish Das the then ACP Traffic East, SPC for the enquiry and submission of findings at an early date. On his transfer to Jalpaiguri the file was again re-endorsed to Shri Ashish P Subba, Assistant Commissioner of Police (West) SPC.
