## PART – II (ORDERS BY THE COMMISSIONER OF POLICE AND DEPUTY COMMISSIONER OF POLICE)

Co NO-830 Date. 01.03.2023

Whereas, information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

Now therefore, in exercise of the power conferred by Sub-section (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) I, Akhilesh Chaturvedi, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of foodgrains and foodstuff i.e. rice, paddy, sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from 20th February-2023 to 20th April-2023.

**WHEREAS**, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

**WHEREAS**, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venues;

**NOW, THEREFORE,** in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (2 of 1974) **I, Akhilesh Chaturvedi, IPS,** Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

- In exercise of power conferred upon me u/s- 144 (2) Cr.P.C. direct that 5(five) or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
- Prohibit assembly of five (5) or more persons within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- Prohibit plying of loud speaker, microphone etc in and around 100 (one hundred) meters of examination venues.
   Use of Mobile Phones in an around 100 (one hundred) meters except the invigilators & venue in-charge is strictly prohibited; and
- 4. I do hereby also prohibit entrance of any person except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till its completion; and
- Prohibit all the Photo Copying Centers & Cyber Cafes located within 100 (One hundred) meters from the examination venues on the days of examination as aforesaid from 07:00 a.m. till completion of examination process; and

Final Order in connection with Siliguri Police Commissionerate Proceeding No. 03/2023 dated 17.01.2023 drawn up against Shri Ashim Gope, Inspector of Police, Siliguri Police Commissionerate erstwhile I/C Balurghat PS, Dakshin Dinajpur.

As per provision of Rule 861 of Police Regulation in Bengal, 1943, Shri Ashim Gope Inspector of Police, Siliguri Police Commiossionerate erstwhile I/C Balurghat PS, Dakshin Dinajpur was charged with gross negligence and dereliction of duty in the following manner that :-

During his incumbency as I/C Balurghat PS, Dakshin Dinajpur, he was entrusted to investigate Balurghat Police Station Case No. 447/2019 dated 30.08.2019 u/s 379 IPC as 5<sup>th</sup> I.O. Although, he took up the investigation on 02.07.2021 and continued it upto 07.06.2022 i.e. about 310 days, however, no significant progress could be made during he said tenure. The following latches were detected on his part:-

- 1. No. efforts were taken to ascertain the reasons of significant delay in lodging the F.I.R. of the said case where the date of occurrence was on 12.03.2018 and the date on which the complaint was lodged was on 30.08.2019.
- 2. No documentary evidences were seized in connection with the alleged cheque amounting of Rs. 25,000/- (Rupees twenty five

thousand) and the bank statement for debiting details of the said cheque in question.

- 3. No verification or seizure has been done for the original printed pass book of the Account Number, Resolution Book, details of vocation fund, allotted fund for purchasing students materials, all formal procedural documents maintained by the school and the managing committee for authorizing the purchase matter out of Government fund, etc.
- 4. No Notice has been served u/s 91 Cr. P.C. to the complainant to submit relevant document in support of his complaint.
- 5. No statement of the eye witness of the act of crime has been arranged to record u/s 164 Cr.P.C.
- 6. No angle of motive could be substaintiated after a lapse of so many days.
- 7. No cross verficication of the allegation of misappropriation of Government Fund by the Head Master of Nazipur High School (Ref: Balurghat Police Station Case No. 633/2011 dated 07.12.2011 u/s 420/478/471 IPC, which was chargesheeted vide Balurghat Police Station Charge Sheet No. 33/2013 dated 31.01.2013 u/s 420/468/471 IPC against the accused namely Shri Pranab Kishore Sarkar and others) reflected in the case dockets in spite of presence of many contradictions in the CDs to the alleged complaint.

A copy of the Charge, Statement of Allegation alonwith other connected/relevant documents were duly served upon the aforesaid officer vide this office Memo. No. 13 Pers-II/Pers-II-101/2022 dated 06.01.2023. On receipt of the same, the Charged Officer submitted his written explanation on 09.02.2023 wherein he pleaded guilty to the charges leveled against him and requested to excuse him for his unintentional mistake.

Accordingly, the Charged Officer was called for personal hering before the undersigned on 24.02.2023 vide this office Org. No. 12 Pers-II/Pers-II-101/2022 dated 17.02.2023. |He appeared for personal hearing on that very date. I heard him. He once again pleaded guilty to the charges and assured that such type of the act would not re-occure in future. He also requested to consider his case sympathetically as he is one of the short listed officers for promotion to the next higher rank.

I have also gone through the service recored of the concerned officer. He has been awarded 74 times in his entire service career, till date.

Considering every aspect together that came up during the hearing. I am inclined to take a lenient view and pass the following. Final Order with an open and judicious mind, free from any bias whatsoever:-

- (4) All the raids by him to arrest the absconded accused persons did not corroborate with the personal Diary, Case Diary and general Diary of Matigara PS.
- (5) His PDs were not in a format. He did not submit PDs on time and PD of various dates are missing in between. Despite of written & verbal reminders of superiors he did not submit Case Diaries regularly which hampered supervision of the case.
- (6) During investigation of the said case he did not make sincere efforts to complete the investigation within 60 days which is mandatory in rape & POCSO Cases.

His such perfunctory investigation, gross negligence & dereliction of duty showed an aberration from the ethics of disciplined Police department.

The Charged SI (UB) Sanjoy Ghosh received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 15/02/2020. In his written reply dated 18/02/2020, he did not plead guilty to the charge drawn up against him and preferred an open enquiry. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the charged officer to defend herself for the sake of natural justice. Although he had prepared the said supplementary Charge sheet along with the Chemical Examination report on 12.10.2022 but submitted it to the Ld. Special court under NDPS Act, Siliguri only on 25.11.2022. Being the I.O of the case he had failed to submit the Supplementary Charge sheet with Chemical report on time due to which the accused person Barasal Seikh had granted bail by the Ld. Court on 03.11.2022.

His such perfunctory investigation, gross negligence & dereliction of duty showed an aberration from the ethics of disciplined Police department and tantamount to infringement of Rule nos. 03 & 04 of West Bengal Govt. Servants' Conduct Rules, 1959.

The Charged SI (UB) Shekhar Adhikary received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 09/02/2023. In his written reply dated 16/02/2023, he pleaded guilty to the charges drawn up against him and did not preferred an open enquiry.

The Charged SI (UB) Shekhar Adhikary was heard by the undersigned personally on 15/03/2023, wherein he again admitted his guilt and begged for mercy.

In view of all that has been stated above, it is evident that the charged officer is guilty of the charges framed against him in the departmental proceeding. He himself has pleaded guilty, which has confirmed that his admission of guilt is at his freewill after being fully aware of the charges and implication of his admission.

After applying my mind judiciously, I pass the Final Order as:-

"The pay of the Charged SI (UB) Shekhar Adhikary is withheld by 01 (one) increment from the next date of his increment for 01 (one) year without cumulative effect."

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
