Tentative procurement value based on previous records is Rs.5,00,000/- (Rupees Five Lakh only) taking all items put to tender. It may change as per actual requirement.

- The Office reserves the right to accept or reject any quotation without stating the reason whatsoever.
- The quotations will be kept at the custody of the Dy. Commissioner of Police (HQ), Siliguri Police Commissionerate (SPC).
- All the articles to be delivered must be according to the sample/Specification. The representatives of intended bidders are advised to visit the Motor Transport Section, Siliguri Police Commissionerate (SPC) to inspect the sample/Quality specification on any working date before submission of bids.
- Bidders willing to participate shall maintain buffer stock at Siliguri to ensure timely supply on placement of requisition.
- The bidder/bidders concerned whose quotation will be accepted must supply the articles within 07 (seven) days from the date of requisition of the same failing which their offer will be rejected without notice and they will be blacklisted for any subsequent purchase of articles from this office.
- Intended Bidders shall have to deliver requisitioned items to the Motor Transport section of Siliguri Police Commissionerate (SPC) on requisition by the competent authority at their own costs of bidders.
- No additional costs on any kind on carrying / transportation/local taxes/insurances/other duties and levies etc whatsoever etc. shall be entertained over and above accepted item rate discovered through financial bids of technically qualified bidders on supply and replacement if any within stipulated time.
