sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from  $9^{th}$  June-2023 to  $7^{th}$  August-2023.

## (ORDERS BY THE COMMISSIONER OF POLICE AND DEPUTY COMMISSIONER OF POLICE)

Whereas, information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

Now therefore, in exercise of the power conferred by Sub-section (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) I, Akhilesh Chaturvedi, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of foodgrains and foodstuff i.e. rice, paddy,

Whereas, information has been received from credible sources that violence demonstrations are likely to take place resulting in large scale disturbance of the public tranquillity and breach of the peace in the area mentioned in the schedule below of the NJP PS, under the Siliguri Police Commissionerate.

#### And

**Whereas,** I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Home (Police) Department order No. 4297-PL/PB/4P-27/11 dt. 04.08.12 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974).

And

Whereas, in my opinion, there is sufficient ground for proceeding under the said section for immediate prevention of disturbances of public tranquillity and breach of peace within the area-in-question of the Siliguri Police Commissionerate.

#### And

Now therefore, in exercise of the power conferred by Sub-section (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) read with the sub-Section (3) of the said Section, I, Akhilesh Chaturvedi, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit for the period 60 (sixty) days from 27th June 2023 to 25th August 2023 until further order, any assembly of 05 (five) or more person in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquillity and breach of the peace within the said area of NJP PS, Siliguri Police Commissionerate.

The area within the jurisdiction of NJP PS bounded:

- 1) On the North By: Power Grid Guest House.
- 2) On the East by : Residential Apartment styled as "Basundhara Abasan".
- 3) On the West by: NH-34.
- 4) On the South by: Feeder Road at Kamrangaguri.

WHEREAS, a message received from Additional Director General & Inspector General of Police, Law and Order, West Bengal vide Memo. No. 114 (2)/CR Dated. 21.06.2023 and Sub Divisional Officer, Siliguri vide Memo. No. 352/Exam Dated 26.06.2023 indicates that the Union Public Service Commission, New Delhi is going to conduct Enforcement Officer/Accounts Officer and Assistant Provident Fund Commissioner in EPFO Examination, 2023 on 02.07.2023 (Sunday) from 09.30 hrs to 11.30 hrs and from 14.00 hrs to 16.00 hrs in 15 (Fifteen) Venues (List Enclosed) within the area of Siliguri Police Commissionerate area;

**WHEREAS**, there is apprehension of breach of peace and tranquillity on the day of examination in the vicinity of the examination venues;

**WHEREAS**, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

**WHEREAS**, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venue;

**NOW, THEREFORE**, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure,

1973 (2 of 1974) **I, Akhilesh Chaturvedi, IPS**, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

- I in exercise of power conferred upon me U/S- 144
   (2) Cr.P.C. I do hereby direct that 5(five) or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
- 2. Prohibit assembly of **five (5) or more persons** within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- Prohibit plying of loud speaker, microphone etc in and around 200 (two hundred) meters of examination venues. Use of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue in-charge is strictly prohibited;
- 4. I do hereby also prohibit entrance of any person(S) except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
- 5. Prohibit all the Photo Copying Centres located within 100 meters from the examination venues on the day (02/07/2023) of examination from 07:00 hrs till examination process is over.
- 6. Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and the order is passed ex-parte u/s 144 (2) of Cr.P.C of 1973.

The charge as drawn up against ASI(UB) 603 Sk. Maksud Ali is summarized below:-

On the night of 07-08/06/2022 at around 02.10 hrs, some rowdies were harassing girls at Gurung Busty under the jurisdiction of Pradhannagar PS. On that night complainant Samiksha Rao along with her colleagues reached Pradhannagar PS to lodge complaints against the rowdies regarding the incident of violence and molestation.

On that night your interaction with victims of molestation and violence was not courteous. You physically assaulted one Anuj Suri, who was with the victim of incident. Your conduct was unbecoming as the duty was not performed in the given manner, which amount to grave dereliction of duty.

The Charged ASI(UB) 603 Sk. Maksud Ali received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 30.06.2022 . In his written reply dated 06/07/2022, he did not plead guilty to the charge drawn up against him and preferred an open enquiry. The Proceedings File No. 17/2022 dated-29/06/2022 was endorsed to Shri Santanu Tarafder, ACP (AP), SPC for the enquiry and submission of findings at an early date. On completion of enquiry, Shri Santanu Tarafder, ACP (AP), SPC submitted his findings on 20.05.2023

I have carefully gone through the deposition of prosecution witnesses, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as twelve P.Ws, concerned seven documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the charged officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 20.05.2023 with the opinion that the charge as drawn up against

ASI(UB) 603 Sk. Maksud Ali is proved beyond the doubt. On 19.06.2023 the charged Officer was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as:

"The Pay of the Charged ASI(UB) 603 Sk. Maksud Ali is withheld by 01 (one) increment from the next date of his due increment for 01 (one) year without cumulative effect"

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.

The charge as drawn up against SI (UB) Phurba Tendu Sherpa is summarized below:-

While being posted at Siliguri PS under Siliguri Police Commissionerate on 09.01.2023 at 14.00 hrs you SI (UB) Phurba Tendu Sherpa were detailed to perform evening GDE-II duty . On the same day in evening hours LC-1282 Swastika Sharma who was engaged in Siliguri PS Office duty received an e-mail message addressing to the MLA Siliguri assembly Shri Shankar Ghosh. Accordingly, seeing the importance of the message LC-1282 Swastika Sharma took the print of the message and asked you to serve the message to K-22 van officer. But being denied by you, when LC-1282 Swastika Sharma herself went to call through land phone beside the Duty Officer table you being seated beside, touched her backside improperly. Your such act showed an aberration from the ethics of the disciplined department and tarnished the image of Police Department in the eye of common people.

The Charged SI (UB) Phurba Tendu Sherpa received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 09.02.2023. In his written reply dated 01.03.2023, he did not plead guilty to the charge drawn up against him and preferred an open enquiry. The Proceedings File No. 05/2023 dated-07/02/2023 was endorsed to Shri Manish Kumar Yadav, ACP (Investigation Unit), SPC for the enquiry and submission of findings at an early date. On completion of enquiry, Shri Manish Kumar Yadav, ACP (Investigation Unit), SPC submitted his findings on 23.05.2023

I have carefully gone through the deposition of prosecution witnesses, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as four P.Ws, concerned five documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the charged officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 23.05.2023 with the opinion that the charge as drawn up against SI (UB) Phurba Tendu Sherpa is proved beyond the doubt.

On 19.06.2023 the charged Officer was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as :-

"The Pay of the Charged SI (UB) Phurba Tendu Sherpa is immediately reduced by 01 (one) increment with cumulative effect"

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
