WHEREAS, a message received from Additional Director General & Inspector General of Police, Law and Order, West Bengal vide Memo. No. 135 (34)/CR Dared. 13.07.2023 indicates that the West Bengal Joint Entrance Examinations Board is going to conduct ANM & GNM-2023 [08 Centre] from 11.00 hrs to 12.30 hrs and JECA-2023 [01 Centre] from 14.00 hrs to 16.00 hrs on 23.07.2023 and PUMDET-2023 [01 Centre] from 12.00 hrs to 13.30 hrs on 30.07.2023 within the area of Siliguri Police Commissionerate;

WHEREAS, there is apprehension of breach of peace and tranquillity on the day of examination in the vicinity of the examination venues;

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in


connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venue;

NOW, THEREFORE, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (2 of 1974) **I, Akhilesh Chaturvedi, IPS**, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

- I in exercise of power conferred upon me U/S- 144

 (2) Cr.P.C. I do hereby direct that 5(five) or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
- 2. Prohibit assembly of **five (5) or more persons** within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- 3. Prohibit plying of loud speaker, microphone etc in and around 200 (two hundred) meters of examination venues. Use of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and
- 4. I do hereby also prohibit entrance of any person(S) except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
- 5. Prohibit all the Photo Copying Centres located within 100 meters from the examination venues on the day of examination from **08:00 hrs till examination process is over**.
- 6. Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and the order is passed ex-parte u/s 144 (2) of Cr.P.C of 1973.

Whereas, information has been received from O.C Matigara PS, SPC that protest demonstrations are likely to take place before the BDO Matigara at his office, Shibmandir, Matigara PS being led by BJP District Level Leaders for their various demands, resulting in large scale disturbance of the public tranquillity and breach of the peace in the area of mentioned Matigara PS, under the Siliguri Police Commissionerate.

And

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Home (Police) Department order No. 4297-PL/PB/4P-27/11 dt. 04.08.12 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974).

And

Whereas, in my opinion, there is sufficient ground for proceeding under the said section for immediate prevention of disturbances of public tranquillity and breach of peace within the area-in-question of the Siliguri Police Commissionerate.

And

Now therefore, in exercise of the power conferred by Sub-section (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) read with the sub-Section (3) of the said Section, **I, Akhilesh Chaturvedi, IPS**, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit assembly of **five (5)** or more persons within the radius of 100 (one hundred) meters of the periphery of the office of BDO Matigara within the Siliguri Police Commissionerate area on 21/07/2023 from 08:00 hrs to 18:00 hrs or the doing of any act which is likely to cause disturbances to the public tranquillity and breach of the peace within the said mentioned area of Matigara PS, Siliguri Police Commissionerate.

FINAL ORDER PASSED BY SHRI JOY TUDU, IPS, DY. COMMISSIONER OF POLICE (HQ) SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO. 04/2022 DTD. - 29/03/2022 DRAWN UP AGAINST ASI (UB) 440 RAMPRASAD ADHIKARY OF SILIGURI POLICE COMMISSIONERATE

ASI (UB) 440 Ramprasad Adhikary of Siliguri Police Commissionerate was charged with moral turpitude, indiscipline conduct and dereliction of duty unbecoming of a member of Police Force.

The charge as drawn up against ASI (UB) 440 Ramprasad Adhikary is summarized below:-

On 04.03.2022 a written complaint was reported against ASI (UB) 440 Ramprasad Adhikary from one Prafulla Barman, s/o Naresh Barman resident of Adarsha Pally under Ambari O.P, SPC to the effect that he demanded money from the said complainant by threatening of putting him behind the Bar. When he was asked the reason behind it, then ASI (UB) 440 Ramprasad Adhikary told the complainant that one Paritosh Das had lodged a case against him related to land. He took Rs.5000 (Rupees Five thousand) from the complainant with a same reason of putting him behind the Bar. Over this, enquiry was conducted by Shri Shubhendra Kumar, IPS Asstt. Commissioner of Police (East-II), SPC vide Memo No 563/22 dated 23.03.2022 where one Paritosh Das had come to Ambari OP and complained verbally before the duty officer ASI (UB) 440 Ramprasad Adhikary against one Prafulla Barman, who had borrowed money from him. But, on the next day, without informing the matter to O/C Ambari OP, ASI (UB) 440 Ramprasad Adhikary met Prafulla Barman and demanded money from him. During enquiry by ACP (East-II), SPC, he failed to give any reason as to why he went for the said enquiry without giving any knowledge to the O/C Ambari OP. It was also found that he was involved in similar other cases under Milanpally OP area. His such act has tarnished the image of disciplined Police department in the eye of common people.

The charged ASI (UB) 440 Ramprasad Adhikary received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 29.03.2022. In his written reply dated 04.04.2022, he did not plead guilty to the charges drawn up against him and preferred an open enquiry. The Proceedings File No. 04/2022 dated 29.03.2022 was endorsed to Shri Kukil Ch. Roy, the then Assistant Commissioner of Police (Investigation Unit), SPC as E.O. for the enquiry and submission of findings at an early date. Due to his superannuation the file was again re-endorsed to Shri Manish Kumar Yadav, Assistant Commissioner of Police (Investigation Unit), SPC as E.O. for the enquiry and submission of findings at an early date.

On completion of enquiry, the E.O. Shri Manish Kumar Yadav, Assistant Commissioner of Police (Investigation Unit), SPC submitted his findings on 23.06.2023.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as four P.Ws, concerned five documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 23.06.2023 with the opinion that the Charged labelled against the CO could not be established.

On 20.07.2023 the Charged ASI (UB) 440 Ramprasad Adhikary was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as:-

"After careful consideration of all the pros & cons of the proceedings file, the Charged ASI (UB) 440 Ramprasad Adhikary is exonerated from the all charges as levelled against him and the Proceeding is **filed**."

As per Rule 883 of PRB Vol –I the Charged Const. is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.

FINAL ORDER PASSED BY SHRI JOY TUDU, IPS, DY. COMMISSIONER IN C/W THIS UNIT PROCEEDING NO 12/2023 DATED-20.03.2023 DRAWN UP AGAINST SI(UB) RAJU SARKAR OF SILIGURI POLICE COMMISSIONERATE

SI(UB) Raju Sarkar of Siliguri Police Commissionerate was charged with moral turpitude, indiscipline conduct and dereliction of duty unbecoming of a member of Police Force.

The charge as drawn up against SI(UB) Raju Sarkar_is summarized below:-

While being posted at Baishnabnagar PS and Kaliachak PS under Malda District as ASI, he [SI (UB) Raju Sarkar] was endorsed to investigate cases. You took departure from Malda District on 31/12/2016 to join Siliguri Police Commissionerate on promotion to the rank of Sub-Inspector (UB). But he had kept twenty-two cases pending and had not deposited original cases till date inspite of several formal communication made on several occasions by the concerned ICs of Baishnabnagar PS and Kaliachak PS of Malda District to him. His such careless attitude and negligent act towards investigation as an Investigating Officer is against of ethics of disciplined Police Department.

The Charged SI(UB) Raju Sarkar received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 22.03.2023. In his written reply dated 02.07.2023, he pleaded guilty to the charges drawn up against him and did not preferred an open enquiry.

The Charged SI(UB) Raju Sarkar was heard by the undersigned personally on 20.07.2023, wherein he again admitted his guilt and begged for mercy.

In view of all that has been stated above, it is evident that the charged officer is guilty of the charges framed against him in the departmental proceeding. He himself has pleaded guilty, which has confirmed that his admission of guilt is at his freewill after being fully aware of the charges and implication of his admission.

After applying my mind judiciously, I pass the Final Order as:-

"The pay of the Charged SI(UB) Raju Sarkar is withheld by 01 (one) increment from the next date of his increment for 01 (one) year without cumulative effect."

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
