**WHEREAS**, in c/w ensuing Oath taking ceremony of the newly elected Gram Panchayat Members and Election of Gram Panchayat Pradhan and Upa- Pradhan 2023 is scheduled to be held on **9<sup>th</sup> August, 2023 & 10<sup>th</sup> August 2023 [Venue list enclosed]** under Siliguri Police Commissionerate area as per Ref Memo No. 436/1 (4)/Raj/2023 Dated 31/08/2023 of Block Development Officer, Rajganj, District Jalpaiguri and Notification No. 1469/1/DP/2G-1/2023 Dated 27/07/2023 of Kolkata Gazette Extraordinary of Government of West Bengal.

AND WHEREAS, with the declaration of Oath taking ceremony of the newly elected Gram Panchayat Members and Election of Gram Panchayat Pradhan and Upa- Pradhan 2023, it is considered expedient to issue the following prohibitory orders within the jurisdiction of Siliguri Police Commissionerate going for concerned Venues areas, in the interest of maintaining Law & Order and to prevent danger to human life, disturbance to public tranquillity and also to ensure smooth, free, fair and peaceful Oath taking ceremony.

**NOW, THEREFORE, I, Akhilesh Kumar Chaturvedi, IPS**, Commissioner of Police, Siliguri Police Commissionerate, Siliguri, in view of the volatile atmosphere prevailing in Siliguri Police Commissionerate area, as per specific direction the conduct of Oath taking ceremony of the newly elected Gram Panchayat Members and Election of Gram Panchayat Pradhan and Upa- Pradhan 2023 under Siliguri Police Commissionerate area in exercise of power under sub section 2 of Section 144 Cr.P.C., 1973, on in the said area do hereby prohibited Assembly 05 (five) or more persons within the periphery of 100 meters of any Venues which are likely to turn unlawful in the said area and also prohibit/burn carrying of stones, weapons, firecrackers and others explosive materials on **9<sup>th</sup> August, 2023 & 10<sup>th</sup> August 2023** at specific listed Venues.

This order shall, however, prohibition of assembly will not be applicable to the Elected Members/Officials came in c/w Oath taking ceremony of the newly elected Gram Panchayat Members and Election of Gram Panchayat Pradhan and Upa- Pradhan 2023 which is scheduled to be held on mentioned date and Venue under Siliguri Police Commissionerate area.

Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and order is passed ex-parte u/s 144(2) of Cr.P.C. of 1973.

This order will take immediate effect from 07:00 A.M. on **9<sup>th</sup> August, 2023 & 10<sup>th</sup> August 2023** at specific listed Venues and will remain in force till the completion of the Oath taking process.

1. In exercise of power conferred upon me u/s 144 (2) Cr.P.C. direct that **5 (five)** or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
2. Prohibit assembly of **5 (five)** or more persons within the radius of **200 (Two hundred)** meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
3. Prohibit playing of loud speaker, microphone etc in and around **200 (Two hundred)** meters of examination venues. Use of Mobile Phones in and around **200 (Two hundred)** meters except the invigilators & venue in-charge is strictly prohibited; and
4. I do hereby also prohibit entrance of any person except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
5. Prohibit all the Photo Copying Centers & Cyber Cafe located within **200 (Two hundred)** meters from the examination venues on the day (**06.08.2023**) of examination from **09:00 hrs. to 17:00 hrs.**; and
6. The screening/ frisking team should ensure that no candidate enters the examination venue with any electronic gadgets like tab, i-pod, laptop, calculator, camera, head phones, portable scanner, other accessories and other materials like books, notes etc. which help the candidate during examination; and
7. No guardian or the persons accompanying the candidates should be allowed to enter inside the premises of the venue; and

As per provision of Rule 861 of Police regulation Bengal,1943 Shri Ashim Gope,Inspector of Police, Siliguri Police Commissionerate erstwhile I/C Gangapur Police Station Dakshin Dinajpur was charged with gross misconduct, negligence and dereliction of duty unbecoming of a police officer in the manner that:-

During his incumbency at Gangarampur Police Station as the Officer-in-Charge, a case bearing Gangarampur Police Station Case No-453/2014 dated 11.10.2014 was registered u/s 27(a)/28(A) of Drugs & Cosmetics Act on the basis of written complaint of Inspector Ramashish of 121 Bn.

,BSF 'B' Company BOP,Bhadra ,District-Dakshin Dinajpur and the said case was endorsed to ASI Haridas Chandra Modak of Gangarampur Police Station for investigation. The I.O submitted Charge Sheet vide Gangarampur Police Station Charge Sheet No-218/2015 dated 31.05.2015 u/s 27(a)/28(A) of the Drugs and Cosmetics Act, 1940 after obtaining opinion from the State Drugs Control & Research Laboratory, Kolkata that the Alamat sent contained "Chlorpheniramine Maleate & Codeine Phosphate."

Being the first level supervising officer he failed to note that:-

(i)Although 250 bottels (commercial quantity) of Phensedyl Cough Syrup were recovered, the case was registered u/s 27 (a)/28(A) of the Drugs & Cosmetics Act instead of provision of NDPS Act.

(ii)Even during endorsing the Charge Sheet to the trail Court, he allowed the I.O to submit Cahrge Sheet u/s 27(a)/28(A) of the Drugs & Cosmetics Act which was complete violation of the provision of Sec. 52(A)(3) of the Narcotic Drugs & complete violation of the provision of Sec. 52(A)(3) of the Narcotic Drugs & Psychotropic Substance Rule,1985 and as a result , the accused person namely Latif Miah s/o Lt. Tamisuddin Miah of Basuria, PS- Gangarampur, District- Dakshin Dinajpur was held acquitted from the case.

The Charged officer was provided with the copies of the Charge, Statement of Allegation along with other connected /relevant documents vide this office Memo No- 159 Pres-II/Pers-II-16/2023 dated 24.05.2023.

The receipt of the same, the charged officer submitted his written explanation on 07.06.2023 wherein he pleaded guilty to the charges and expressed the desire to be heard personally.

Accordingly, the charged officer was directed to appear for personal hearing before the undersigned on 28.07.023 vide this office Org No-80 Pers-II/Pers-II-16/2023 dated 18.07.2023. **FINAL ORDER PASSED BY SHRI JOY TUDU, IPS, DY. COMMISSIONER OF POLICE (HO) SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO. 19/23 DTD.-30/07/2023 DRAWN UP AGAINST LC/1289 SANTOSHI GUPTA OF SILIGURI POLICE COMMISSIONERATE**

The charge as drawn up against LC/1289 Santoshi Gupta is summarized below:-

While being posted at Siliguri Police Commissionerate she [LC 1289 Santoshi Gupta] proceeded to avail 180 days Maternity Leave w.e.f. 12.11.2021 P.M to 11.05.2022 PM. But instead of joining duty on 12.05.2022 A.M. she was found overstaying from maternity leave from w.e.f.12.05.2022 A.M. In this context several warning notices were issued to her residential address through I/C Kurseong PS, Darjeeling with a direction to join her duty vide this unit Org No 1116/RO, SPC dated-21.05.2022, Org No. 1223/ RO, SPC Dated- 06.06.2022, Org No. 1265/RO, SPC Dated-11.06.2022, Org No. 1601/ RO, SPC Dated-02.08.2022, Org No. 1914/ RO, SPC Dated- 29.09.2022, Org No. 2332/ RO, SPC Dated- 13.12.2022, Org No. 1120/ RO, SPC Dated-04.07.2023. Later on, she reported her arrival at Reserve Office, Siliguri Police Commissionerate on 07.07.2023 P.M after overstaying from maternity leave for 422 days w.e.f 12.05.2022 A.M to 07.07.2023 P.M.

The charged LC/1289 Santoshi Gupta received the copy of Charge & Statement of Allegation along with all relevant documents under her signature on 02/08/2023. She submitted her written explanation on 06/08/2023, wherein she has pleaded guilty to the charge drawn against her.

The Charged LC/1289 Santoshi Gupta was heard by the undersigned personally on 22/08/2023, wherein she again admitted her guilt and begged for mercy.

In view of all that has been stated above, it is evident that the Charged LC is guilty of the charges framed against her in the departmental proceeding. She herself has pleaded guilty, which has confirmed that her admission of guilt is at his freewill after being fully aware of the charges and implication of her admission. Last but not the least, the documents having exhibited and confirmed by a prosecution witnesses concerned make it beyond all reasonable doubt as to the guilt of the Charged LC of all the charges. Considering the charges and his past service records, she should be meted out with severe punishment.

After applying my mind judiciously, I pass the Final Order as:-

“The pay of the Charged LC/1289 Santoshi Gupta is withheld by 01 (one) increment from the next date of her due increment with cumulative effect.

Her absence period w.e.f. 12/05/2022 A.M. to 07/07/2023 P.M. ( total 422 days) is treated as E.O.L . Held over pay, if any, be released after necessary adjustment.”

As per Rule 883 of PRB Vol –I the Charged LC is at liberty to appeal against this order before the Commissioner of Police , Siliguri Police Commissionerate within 37 (thirty seven) days from the receipt of the copy of the Final Order.

**FINAL ORDER PASSED BY SHRI JOY TUDU, IPS, DY. COMMISSIONER OF POLICE (HO), SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO. 10/2021 DATED-06/09/2021 DRAWN UP AGAINST ASI (UB) 11 BIPLAB KR DAS OF SILIGURI POLICE COMMISSIONERATE**

The charge as drawn up against ASI(UB) 11 Biplab Kr Das is summarized below:-

While being attached with Bhaktinagar PS under Siliguri Police Commissionerate, on the night of 22-23/08/2021 he (ASI Biplab Kr. Das) had been sent to Ashrafnagar colony to control chaos and commotion between some youths of Salugara and two persons of Ashrafnagar colony. But on that night Md Ashiq Mallick @Guddu was threatening the opposite party with weapons in front of him. After the incident he didn't inform the incident of carrying weapons to I/C Bhaktinagar PS, SPC. His such gross negligence & dereliction of duty showed an aberration from the ethics of disciplined Police department and tantamount to infringement of Rule nos. 03 & 04 of West Bengal Govt. Servants' Conduct Rules, 1959.

The Charged ASI(UB) 11 Biplab Kr Das received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 07.09.2021 . In his written reply dated 11/09/2021, he did not plead guilty to the charge drawn up against him and preferred an open enquiry. The Proceedings File No. 10/2021 dated-06/09/2021 was endorsed to Shri Manabendu Sekhar Rakshit the then ACP, EB, SPC for the enquiry and submission of findings at an early date. On his superannuation the file is re endorse to Shri Passang Topgay Bhutia, ACP(Traffic) East, SPC on completion of enquiry, Shri Passang Topgay Bhutia, ACP(Traffic) East, SPC submitted his findings on 31.07.2023

I have carefully gone through the deposition of prosecution witnesses, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as three P.Ws, concerned four documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the charged officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 31.07.2023 with the opinion that the charge as drawn up against ASI(UB)11 Biplab Kr Das proved beyond the doubt.

On 22.08.2023 the charged Officer was heard by me personally, wherein he plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as:-

“The Pay of the Charged ASI(UB)11 Biplab Kr Das is withheld by 01 (one) increment from the next date of his due increment with cumulative effect”

Suspension period of the Charged ASI(UB)11 Biplab Kr Das w.e.f. 26/08/2021 A.M. to 06/09/2021 P.M. is confirmed that means Charged officer will not get anything apart from subsistence allowance whatever he has drawn.”

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.

**FINAL ORDER PASSED BY SHRI JOY TUDU, IPS, DY. COMMISSIONER IN C/W THIS UNIT PROCEEDING NO-15/2022 DTD. 22.06.2022 DRAWN UP AGAINST PSI (UB) KRISHNA PARJA OF SILIGURI POLICE COMMISSIONERATE**

The charge as drawn up against PSI (UB) Krishna Parja is summarized below:- On the night of 07-08/06/2022 at around 02.10 hrs while he [PSI (UB) Krishna Parja] was performing K-30 Van night mobile duty, one Anarul Islam informed him that some rowdies were harassing girls at Gurung Busty. Accordingly he reached at the spot but did not make efforts to arrest all the accused immediately who are involved in molestation and violence against victim girls. He deliberately suppressed information regarding the incident of violence and molestation against Girls to the duty officer SI Khela Murmu. He concocted the story and lodge a false complaint against colleagues of victim of violence i.e Anuj Suri, Sourav Sarkar, Mingma Sherpa and Adarsh Tamang. Investigation of crime against Women are matter of great concern for the Police Department. Free and prompt registration of cases, quality investigation, proper and expeditious prosecution ending in conviction of the offender shall be a eterrant in combating the menace. But all tenets of SOP for investigation of crime against women are ignored by him in connection with this incident.

**Additional Charge**

On 04.08.2022 , in c/w WPA 1775 of 2022 Anuj Suri Vs The State of West Bengal & Ors, Hon'ble Justice Abhijit Gangopadhyay of Circuit Bench of Calcutta High Court at Jalpaiguri observed on the basis of allegation that on the night of 07-08/06/2022 the petitioner Anuj Suri who was with the victims was put inside the PS lockup, where he was severely beaten and was in Jail in false case for 24 days. He, PSI (UB) Krishna Parja being the on-duty CS Van Officer and also the complainant of the case on the basis of which the petitioner was put inside the lockup , should have ensure the rules carried upon the accused inside the Hazat. Therefore, in no situation, he can deny the liability regarding the petitioner not only being beaten up inside the PS lockup but also being deprived of the liberty. Thus, he has blatantly violated the fundamental right of the petitioner, which is an incident of Police atrocities.

The Charged PSI (UB) Krishna Parja received the copy of Main Charge & statement of allegation along with all relevant documents under his signature on 23.06.2022 and the copy of Additional Charge statement of allegation along with all relevant documents under his signature on 05.08.2022. In his written reply dated 24.06.2022 in c/w main charge & written reply dated-05.08.2022 in c/w additional charge , the Charged Officer did not plead guilty to the charges drawn up against him and preferred an open enquiry. The Proceeding file was endorsed to Shri Shubhendra Kumar IPS, ACP (East-I), SPC for the enquiry and submission of findings at an early date. On Completion of enquiry Shri Shubhendra Kumar IPS, ACP (East-I), SPC submitted his findings on 04.11.2022.

I have carefully gone through the deposition of prosecution witnesses, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as twelve (12) P.Ws for main charge and eight (08) P.Ws for additional charge, ten (10) Defence Witness & concerned nine (09) documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the charged officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 04.11.2022 with the opinion that two (02) out of the total four (04) Charges were proved against the Charged Officer .On 22.08.2023 the charged Officer was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as :-

“The Pay of the Charged PSI (UB) Krishna Parja is withheld by 01 (one) increment from the next date of his due increment for 01(one) year without cumulative effect”.

Suspension period of the Charged PSI (UB) Krishna Parja w.e.f. 17.06.2022 a.m to 31.07.2022 p.m is confirmed that means Charged officer will not get anything apart from subsistence allowance whatever he has drawn and on 01.08.2022 a.m he was posted at Bagdogra PS, SPC. He was on duty at Bagdogra PS, SPC w.e.f 01.08.2022 to 02.08.2022 and on 03.08.2022 he was closed to Line OR, SPC. Suspension period from 04.08.2022 a.m onwards is confirmed and release date of suspension will be decided after the order of Hon'ble High Court Calcutta, Circuit Bench at Jalpaiguri.”

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
