WHEREAS, a message received from Sub Divisional Officer, Siliguri vide Memo. No. 459/ Exam Dated. 29.08.2023 indicates that Combined Defence Service Examination (II), 2023 will be held on **03.09.2023 (Sunday)** from 09.00 hrs to 11.00 hrs for Paper-I (English),

12.00 hrs to 14.00 hrs for Paper-II (General Knowledge) and 15.00 hrs to 17.00 hrs for Paper-III (Elementary Mathematics) [Note: The Exam will be held in 2/3 Sessions. The Paper-III will be held in some Venues only which will be intimated to concerned Supervisors separately.] being conducted by the Union Public Service Commission, New Delhi. A total number of candidates 2933 (Two Thousand Nine Hundred and Thirty Three) are supposed to appear in the Examination at 07 (Seven) Venues (Siliguri Centre) (**List Enclosed**) within the area of Siliguri Police Commissionerate.

WHEREAS, there is apprehension of breach of peace and tranquillity on the day of examination in the vicinity of the examination venues;

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquillity on the aforesaid day in and around the examination venue;

NOW, THEREFORE, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (2 of 1974) **I, Akhilesh Kumar Chaturvedi, IPS**, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

1. I in exercise of power conferred upon me U/S- 144 (2) Cr.P.C. I do hereby direct that **5(five) or more person**, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
2. Prohibit assembly of **five (5) or more persons** within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
3. Prohibit plying of loud speaker, microphone etc in and around 200 (two hundred) meters of examination venues. Use of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and
4. I do hereby also prohibit entrance of any person(S) except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
5. Prohibit all the Photo Copying Centres located within 100 meters from the examination venues on the **days (03/09/2023)**

of examination from **07:00 hrs till examination process is over.**

A Total number of Candidates **11,513 (Eleven Thousand Five Hundred and Thirteen)** are supposed to appear in the Written Examination at **24 (Twenty Four) Venues (List enclosed)** (Siliguri Town Centre Code No.13) within the area of Siliguri Police Commissionerate;

WHEREAS, there is apprehension of breach of peace and tranquility on the day of examination in the vicinity of the examination venues;

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venue;

NOW, THEREFORE, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (2 of 1974) **I, Akhilesh Kumar Chaturvedi, IPS**, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

- In exercise of power conferred upon me u/s 144 (2) Cr.P.C. direct that **5 (five)** or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
- Prohibit assembly of **5 (five)** or more persons within the radius of **200 (Two hundred)** meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- Prohibit playing of loud speaker, microphone etc in and around **200 (Two hundred)** meters of examination venues. Use of Mobile Phones in and around **200 (Two hundred)** meters except the invigilators & venue in-charge is strictly prohibited; and
- I do hereby also prohibit entrance of any person except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
- Prohibit all the Photo Copying Centers & Cyber Cafe located within **200 (Two hundred)** meters from the examination venues on the day (**10.09.2023**) of examination from **09:00 hrs. to 14:00 hrs.**; and

- The screening/ frisking team should ensure that no candidate enters the examination venue with any electronic gadgets like tab, i-pod, laptop, calculator, camera, head phones, portable scanner, other accessories and other materials like books, notes etc. which help the candidate during examination; and
- No guardian or the persons accompanying the candidates should be allowed to enter inside the premises of the venue; and
- Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and the order is passed ex-parte u/s 144(2) of Cr.P.C of 1973.

SPC as E.O. for the enquiry and submission of findings at an early date. On completion of enquiry, the E.O. Shri Suraj Thakuri, Assistant Commissioner of Police (HQ), SPC submitted his findings on 31.08.2023.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as five P.Ws, concerned two documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 31.08.2023 with the opinion that the Charged made against SI (UB) Md. Ziaul Hoque could not be proved either from the examination of PWs nor from the exhibits given during open enquiry of this proceeding. On 22.09.2023 the Charged SI (UB) Md. Ziaul Hoque was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as:-

He, being a senior Sub Inspector failed to comply the order of the Hon'ble Circuit Bench due to which same messages on several successive fixed dates was sent from Additional Public Prosecutor, Jalpaiguri Circuit bench of High Court Calcutta, Jalpaiguri and was re-endorsed to him . Consequently due to non-receipt of the case diary of the subject reference and non-cooperation from Bhaktinagar PS, I/C Bhaktinagar PS, SPC was ordered to remain physically present on 01.12.21 and the Hon'ble Circuit Bench gave an order that the Court was in seisin of this matter for two days in the past i.e 22.11.21 & 25.11.21. It is evident that the lapse was from his part that he failed to comply the order of the superior officer and Hon'ble Circuit Bench, Jalpaiguri.

The charged SI (UB) Md. Ziaul Hoque received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 09.12.2021. In his written reply dated 17.12.2021, he did not plead guilty to the charges drawn up against him and preferred an open enquiry.
