WHEREAS, message received from Sub-Divisional Officer, Siliguri vide Memo. No. 179/1(5)/Exam Dated 28.02.2024 indicates that West Bengal Madrasah Service Commission is going to conduct 7<sup>th</sup> SLST (AT) Main Examination is scheduled to be held on 03.03.2024 (Sunday) in two session commencing from 10:30 A.M. to 12:00 noon and 2:30 P.M to 4:00 P.M in a single venue namely Siliguri Boys High School, Siliguri under the area of Siliguri Police Commissionerate;

**WHEREAS**, there is apprehension of breach of peace and tranquility on the day of examination in the vicinity of the examination venue;

**WHEREAS**, it is felt expedient to pass certain direction to prevent obstructions, annoyance or injury to any person employed in connection

with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

**WHEREAS**, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venue;

**NOW, THEREFORE**, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (2 of 1974) **I, C. Sudhakar, IPS,** Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

- I in exercise of power conferred upon me U/S- 144 (2) Cr.P.C. I do hereby direct that five (05) or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
- 2. Prohibit assembly of **five (05) or more persons** within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- Prohibit plying of loud speaker, microphone etc in and around 200 (two hundred) meters of examination venues. Use of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue incharge is strictly prohibited; and
- 4. I do hereby also prohibit entrance of any person(S) except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
- 5. Prohibit all the Photo Copying Centres located within 100 meters from the examination venues on the day of examination from **09:00 hrs till examination process is over**.
- 6. Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and the order is passed ex-parte u/s 144 (2) of Cr.P.C of 1973.

Whereas, information has been received that proposed visit of Hon'ble Prime Minister of India Shri Narendra Modi is being schedule on 09/03/2024 at Kawakhali Ground and its surrounding area P.S Matigara and NJP under Siliguri Police Commissionerate.

And

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Home (Police) Department Order No. 4297-PL/PB/4P-27/11 dt. 04.08.2012 to act under Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974).

Now therefore, in exercise of the power conferred by Sub-section (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) read with the sub-Section (3) of the said Section, I, C. Sudhakar, IPS Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby order that "No drone shall be flown within a distance of 05 (five) km from the periphery of the meeting venue at Kawakhali Ground and its surrounding area P.S Matigara and NJP under Siliguri Police Commissionerate.".

Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and order is passed ex-parte u/s 144(2) of Cr.P.C. of 1973.

This order will take into immediate effect and will remain in force till the completion of the proposed visit.

WHEREAS, message received from Sub Divisional Officer, Siliguri vide Memo. No. 190/Exam Dated.29.02.2024 indicate that the Public Service Commission (PSC), West Bengal is going to conduct the Recruitment to the Post of Sub- Inspector in the Subordinate Food & Supplies Service, Grade -III under Food & Supplies Department on 16.03.2024 (Saturday) & 17.03.2024 (Sunday) in 3 (Three) session from 09:30 a.m. to 11:00 a.m., 12:30 p.m. to 02:00 p.m. and 03:30 p.m. to 05:00 p.m. in each day at 13 Nos. of Exam Centre under Siliguri Police Commissionerate;

**WHEREAS,** there is apprehension of breach of peace and tranquility on the day of examination in the vicinity of the examination venues;

**WHEREAS,** it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

**WHEREAS,** it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venue;

**NOW, THEREFORE,** in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal

Procedure, 1973 (2 of 1974) **I, C. Sudhakar, IPS**, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-


- In exercise of power conferred upon me u/s 144 (2) Cr.P.C. direct that 5 (five) or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
- 3. Prohibit assembly of **5 (five)** or more persons within the radius of **200 (Two hundred)** meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and
- Prohibit playing of loud speaker, microphone etc in and around 200 (Two hundred) meters of examination venues. Use of Mobile Phones in and around 200 (Two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and
- 5. I do hereby also prohibit entrance of any person except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
- Prohibit all the Photo Copying Centers & Cyber Cafe located within 200 (Two hundred) meters from the examination venues on the day (16/03/2024 & 17/03/2024) of examination from 08:00 hrs till examination process is over; and
- 7. The screening/ frisking team should ensure that no candidate enters the examination venue with any electronic gadgets like tab, i-pod, laptop, calculator, camera, head phones, portable scanner, other accessories and other materials like books, notes etc. which help the candidate during examination; and
- 8. No guardian or the persons accompanying the candidates should be allowed to enter inside the premises of the venue; and
- 9. Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and the order is passed ex-parte u/s 144(2) of Cr.P.C of 1973.

Whereas, the Election Commission of India has announced, on 16/04/2024 vide press note ECI/PN/23/2024 that Parliamentary General Election, 2024 will be held on 19<sup>th</sup> April, 2024 & 26th April, 2024 under Siliguri Police Commissionerate and soon after this announcement of the Election schedule, the Model Code of Conduct has come into force with immediate effect;

Whereas, as per guideline of Election Commission of India vide No. 464/INST/2009/EPS dated: 01/09/2009, the Screening Committee, comprising of the District Magistrate. Jalpaiguri / Darjeeling & Commissioner of Police, Siliguri Police Commissionerate is to assess and review all the license holders of firearms and whereas the committee considers it essential to impound and direct to deposit their arms till the completion of election process for ensuring free and fair election;



Whereas, there is every apprehension of breach of peace and tranquility during the election process within the jurisdiction of Siliguri Police Commissionerate during the conduct of the Parliamentary General Election 2024;

Whereas, it is felt expedient to cause immediate prevention of those apprehended danger and arrange for speedy remedy thereof, in the interest of public tranquility, safety of human life, prevention of injury etc;

Whereas, it is essential to maintain the law and order situation under the area of Siliguri Police Commissionerate during the said election;

Whereas, in order to conduct the ensuing Parliamentary General Election 2024 under the area of Siliguri Police Commissionerate, it is expedient to impose restriction on carrying of licensed arms;

Now, therefore, I, C. Sudhakar, IPS. Commissioner of Police, Siliguri Police Commissionerate, Siliguri, District- Darjeeling in exercise of the power conferred up under Sec. 144 (2) of the code of Criminal procedure do hereby impose ban on the carrying of Arms & Ammunition within the area of Siliguri Police Commissionerate;

This order will take immediate effect and will remain in force until further order.

#### C.O. No. 1514

**WHEREAS,** The Election Commission of India has declared the Parlimantary General Election 2024 in the state of West Bengal as well as in other sates of India, which will commence on & from 19.04.2024 till the completion of election process.

And WHEREAS it is apprehended that there may be breach of peace and public tranquallity in the different localities within the jurisdication of the Siliguri Police Commissionerate during the process of Election.

Now. Therefore, the Licenced arms holders are hereby ordered to deposit their Arms and ammunitions to their respective Police Stations within 21 st March 2024 without fail and the Arms and ammunitions so deposited wil remain in custody of the Police Station til the Election process is over.

Arms of Financial Institutions / Jewellery shops/ Banks / Security Agencies etc. are to be exempted after proper security by the screnning committee of the Siliguri Police Commissionerate.

The Inspector- in -charges & Officer- in- Charges of Siliguri Police Station, Pradhan Nagar Police Stations, Bhaktinagar Police Station, Matigara Police Station, Bagdogra Police Station, New Jalpaiguri Police Station, Bhorer Alo Police Station and all Ops & TOPs under the Siliguri Police Commissionerate Jurisdication are hereby directed to ensure proper implementation of this order.





#### FINAL ORDER PASSED BY SHRI TANMOY SARKAR, IPS, DY. COMMISSIONER OF POLICE (HQ) SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO-. 28/2023 DATED-30.11.2023 DRAWN UP AGAINST CONST-1444 JOYDEEP ROY CHOWDHURY OF SILIGURI POLICE COMMISSIONERATE

The charge as drawn up against Const- 1444 Joydeep Roy Chowdhury is summarized below:-

While being posted at Siliguri PS under Siliguri Police Commissionerate he [C/1444 Joydip Roy Chowdhury] was found unauthorised absent w.e.f 03.07.2022. In this context several warning notices were issued to him at his residential address through O/C Birpara PS, Alipurduar District with a direction to join his duty within 24hrs vide this unit Org No-1420/RO, SPC Date-05.07.2022, Org No-1473/RO, SPC Date-14.07.2022, Org No-1599/RO, SPC Date-02.08.2022, Org No-1635/RO, SPC Date-09.08.2022, Org No-1915/RO, SPC Date-29.09.2022, Org No-2334/RO, SPC Date-13.12.2022. He reported his arrival at Reserve Office, Siliguri Police Commissionerate on 19.12.2022 after staying unauthorized absent for 170 days. Again on 22.12.2022 a.m he was found unauthorised absent . In this context several warning notices were issued to you at your residential address through O/C Birpara PS, Alipurduar District with a direction to join his duty within 24hrs vide this unit Org No-2382/RO, SPC Date-24.12.2022 , Org No-2392/RO, SPC Date-28.12.2022, Org No-96/RO, SPC Date-23.01.2023, Org No-1116/RO, SPC Date-04.07.2023. He reported his arrival at Reserve Office, Siliguri Police Commissionerate on 18.10.2023 after staying unauthorized absent 301 days.

The charged Const- 1444 Joydeep Roy Chowdhury received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 11.12.2023. He submitted his written explanation on 21.02.2024, wherein he has pleaded guilty to the charge drawn against him.

The Charged Const- 1444 Joydeep Roy Chowdhury as heard by the undersigned personally on 27.03.2024, wherein he again admitted his guilt and begged for mercy.

In view of all that has been stated above, it is evident that the Charged Constable is guilty of the charges framed against him in the departmental proceeding. He himself has pleaded guilty, which has confirmed that his admission of guilt is at his freewill after being fully aware of the charges and implication of his admission. Last but not the least, the documents having exhibited and confirmed by a prosecution witnesses concerned make it beyond all reasonable doubt as to the guilt of the Charged Officer of all the charges. Considering the charges and his past service records, he should be meted out with punishment.

On 27.03.2024 the Charged Const- 1444 Joydeep Roy Chowdhury was heard by me personally, wherein he pleaded guilty.

After applying my mind judiciously, I pass the Final Order as:-

The unauthorized absent period of Const-1444 Joydeep Roy Chowdhury in total **471(four hundred and seventy one) days** w.e.f. 03.07.2022 a.m to 19.12.2022 p.m. (170 days) and w.e.f. 22.12.2022 a.m to 18.10.2023 p.m (301 days) out of which absent period w.e.f 03.07.2022 a.m to 14.12.2022 p. m in total **165 (one hundred and sixty five) days** is treated as **Commuted Leave** and absent Period w.e.f 15.12.2022 a.m to 19.12.2022 p.m. and w.e.f 22.12.2022 a.m to 22.03.2023 p.m in total **96 (ninety six) days** is treated as **E.L** and remaining absent period w.e.f 23.03.2023 a.m to 18.10.2023 p.m in total **210 (two hundred and ten)** days is treated as **E.O.L.** Held over pay, if any, be released after necessary adjustment. The Proceeding against Const-1444 Joydeep Roy Chowdhury is **dropped**.

As per Rule 883 of PRB Vol –I the Charged Const. is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.

FINAL ORDER PASSED BY SHRI TANMOY SARKAR, IPS, DY. COMMISSIONER OF POLICE (HQ) SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO. 13/2020 DATED-25.04.2020 DRAWN UP AGAINST ASI (UB) 1029 SUMAN RANA OF SILIGURI POLICE COMMISSIONERATE

The charge as drawn up against ASI (UB) 1029 Suman Rana is summarized below:-

On 05/04/2020 at 09.15 hrs. he [ASI (UB) 1029 Suman Rana] was detailed for Highway patrol duty for 24 hrs by I/C Control Room, SPC. On that day at around 10.35 hrs. instead of being on duty, he came to the PS and without any provocation intended to insult the modesty of LC/ 1281 Pabitra Rai of Bagdogra PS, who was on sentry duty by uttering such words and showing gestures which intruded her privacy. In addition, on 21/12/2019 he had entered into her place of stay in intoxicated condition and abused her verbally and sexually. His such act showed an aberration from the ethics of the disciplined department and tarnished the image of Police Department in the eye of common people.

The charged ASI (UB) 1029 Suman Rana received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 25.04.2020 . He submitted his written explanation on 28.04.2020, wherein he did not plead guilty to the charges drawn up against him and preferred an open enquiry. The Proceedings File No. 13/2020 dated-25.04.2020 was endorsed to Shri



Narendra Kalicotay, the then Assistant Commissioner of Police (SB), SPC as E.O. for the enquiry and submission of findings at an early date. On completion of enquiry, the E.O. Shri Narendra Kalicotay, the then Assistant Commissioner of Police (SB), SPC submitted his findings on 08.02.2024.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as 11 (eleven) P.Ws, concerned 10 (ten) documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to defend himself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 08.02.2024 with the opinion that the charges as drawn up against him could not be proved.

On 27.03.2024 the Charged ASI (UB) 1029 Suman Rana was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as:-

"After careful consideration of all the pros & cons of the proceedings file, the Charged Officer ASI (UB) 1029 Suman Rana is exonerated from the all charges as levelled against him and the Proceeding is **filed**.

Hence his suspension period is not confirmed that means suspension period of the Charged ASI (UB) 1029 Suman Rana w.e.f. 07.04.2020 P.M. to 19.10.2020 P.M. is treated as duty."

As per Rule 883 of PRB Vol –I the Charged Officer. is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.

Heard her explanation is not found to be satisfactory.


