**Whereas,** information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

Now therefore, in exercise of the power conferred by Sub-section (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of food grains and foodstuff i.e. rice, paddy, sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh

International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from  $1^{st}$  April 2024 to  $30^{th}$  May 2024.

**Whereas,** information has been received regarding the proposed arrival and departure of Hon'ble Prime Minister of India Shri Narendra Modi on 16/04/2024 from Bagdogra Airport & Air Force Station under Bagdogra PS, Siliguri Police Commissionerate.

**Whereas,** I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Home (Police) Department Order No. 4297-PL/PB/4P-27/11 dt. 04.08.2012 to act under Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974).

**AND WHEREAS,** it is considered necessary to issue direction to prevent obstructions, annoyance or injury to any person lawfully employed or danger to human life, safety or disturbance of the public tranquility or riot or affray during the conduct of General Election to the 18<sup>th</sup> Lok Sabha-2024 within the jurisdiction of Siliguri Police Commissionerate.

NOW, THEREFORE, in pursuance of Gazette Notification No. 464/EPS/2024(1) dated 20/03/2024 of the Election Commission of India, for the smooth conduct of the General Election to the 18<sup>th</sup> Lok Sabha-2024 to be held on 19<sup>th</sup> April, 2024 within the jurisdiction of Siliguri Police Commissionerate, in exercise of power conferred upon me u/s 144(2) of Cr.P.C., I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate, Siliguri, do hereby promulgate this order prohibiting assembly 05 (five) or more persons within the periphery of 200 meters of any polling station premises in the said areas and also prohibit/ban on carrying of stones, weapons, firecrackers and others explosive materials by any person except by the security personnel on Election Duty.

**HOWEVER**, this prohibition of assembly will not be applicable to voters standing peacefully in queue outside the polling stations to cast their votes

This order is passed ex-parte and be served upon all concerned for information and compliance. The order will take immediate effect from 6.00 A.M. of 19<sup>th</sup> April, 2024 and will remain in force till the completion of the polling process.

NOW, THEREFORE, in pursuance of Gazette Notification No. 464/EPS/2024(1) dated 20/03/2024 of the Election Commission of India, for the smooth conduct of the General Election to the 18th Lok Sabha-2024 to be held on 19th April, 2024 within the jurisdiction of Siliguri Police Commissionerate, in exercise of power conferred upon me u/s 144(2) of Cr.P.C., I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate, Siliguri, do hereby promulgate this order prohibiting assembly 05 (five) or more persons, conduct of meeting, rally, gathering, street corner meetings, mass gathering from 6:00 p.m. of 17th April 2024 i.e 48 hours till time specified for completion of the poll. However, only exception of this prohibitory order is applicable to house to house visit during said 48 hours specified in connection with 'door to door campaigning'.

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Home (Police) Department order No. 4297-PL/PB/4P-27/11 dt. 04.08.12 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974).

And

**Whereas,** in my opinion, there is sufficient ground for proceeding under the said section for immediate prevention of disturbances of public tranquillity and breach of peace within the area-inquestion of the Siliguri Police Commissionerate.

And

**Now therefore,** in exercise of the power conferred by Sub-section (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) read with the sub-Section (3) of the said Section, **I,C. Sudhakar, IPS,** Commissioner of Police,

Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit for the period **60** (sixty) days from **22**nd April **2024** to **20**th June **2024** until further order, any assembly of 05 (five) or more person in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquillity and breach of the peace within the said area of NJP PS, Siliguri Police Commissionerate.

**WHEREAS**, there is apprehension of breach of peace and tranquillity on the day of examination in the vicinity of the examination venues;

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examination and other persons;

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination venue;

**NOW, THEREFORE**, in exercise of the power conferred by sub sec (1) read with sub sec (3) of Sec. 144 of the Code of Criminal Procedure, 1973 (2 of 1974) **I, C. Sudhakar, IPS**, Commissioner of Police, Siliguri and Executive Magistrate in relation to the Metropolitan area of Siliguri and being empowered so to do by the State Govt. do hereby-

- I in exercise of power conferred upon me U/S- 144 (2) Cr.P.C. I do hereby direct that 5 (five) or more person, other than examinees, invigilator, support staff and such other person related to the said examination shall not assemble in the compound/ premises/ around the venue of said examination; and
- Prohibit assembly of five (5) or more persons within the radius of 100 (one hundred) meters of the periphery of the examination venue within the Metropolitan area of Siliguri; and

- 3. Prohibit plying of loud speaker, microphone etc in and around 200 (two hundred) meters of examination venues. Use of Mobile Phones in an around 200 (two hundred) meters except the invigilators & venue in-charge is strictly prohibited; and
- 4. I do hereby also prohibit entrance of any person(S) except those concerned with the conduct of the said examination within the compound of the examination venue after the commencement of the examination till the completion; and
- Prohibit all the Photo Copying Centres located within 100 meters from the examination venues on the day (21/04/2024) of examination from 07:00 hrs till examination process is over.

**AND WHEREAS,** the campaigning period ceases to exist after 6:00 p.m. dated 17/04/2024 as per the order of ECI vide No. 464/INST/2007-PLN-1 Dated 08/01/2007 for the District within the jurisdiction of Siliguri Police Commissionerate for which Poll is scheduled on 19<sup>th</sup> April 2024.

**THEREFORE,** in view of free and fair conduct of the General Elections to the 18<sup>th</sup> Lok Sabha, 2024 to be held on 19<sup>th</sup> April 2024 in the District of Jalpaiguri within the jurisdiction of Siliguri Police Commissionerate, this notice is hereby issued that political functionaries/ party workers/procession functionaries/ campaign functionaries etc. who have been brought from outside the constituency and those who are not voters of the constituency, should not continue to remain present in the constituency.

This Notice is issued in the interest of Public service and it will take effect from 6:00 PM dated 17/04/2024 and will remain in force till completion of the poll. Let this Notice be served upon all concerned for information and strict compliance in letter and spirit.

**AND WHEREAS,** the last 72 hour protocols are imperative to be implemented for smooth ensuing of General Elections for Lok Sabha-2024 in 4-Darjeeling PC within the jurisdiction of Siliguri Police Commissionerate.

**NOW, THEREFORE,** on considering the context, **I, C. Sudhakar, IPS,** Commissioner of Police, Siliguri Police Commissionerate, Siliguri hereby proclaim the following orders in exercise of power conferred upon me u/s 144(2) of Cr.P.C. for keeping peace and public order during General Elections for Lok Sabha-2024:

- There shall be no unlawful assembly of 5 (five) persons or more within the 200 mts of polling premises from 6 PM of 24/04/2024 and till the completion of poll.
- ii. There shall be no public display of fire arms and ammunition in whatever manner across the Darjeeling District area within the jurisdiction of Siliguri Police Commissionerate.
- Possession of arms near polling premises shall not be allowed except for authorised personnel carrying out government duty.
- No mobile shall be used within 100 mts from the polling stations except the authorized officials.
- v. There shall be no political campaigning of whatsoever manner from  $6 \, \text{PM}$  of 24/04/2024
- vi. There shall be no parking of vehicles within 200 mts of Polling Stations.
- vii. There shall be no residual posters/electioneering material within the 200 mts of Polling Premises
- viii. There shall be no announcement of results as to exit polls until the last date of last elections of the General Elections for Lok Sabha-2024.
- ix. Political functionaries/party workers/procession functionaries/campaign functionaries etc who have been brought from outside the constituency and those who are not voters of the constituency shall not continue to remain present in the constituency.
- Use of loudspeakers, amplifier or any other device that amplified human voice or otherwise, save and except, Government Personnel on bonafide public service shall be prohibited.
- xi. There shall be close vigil for keeping peace and public order.

Any person, who contravenes this order shall be liable to be punished in accordance with the provision of Section 188 of the IPC and other relevant provision of law. As the notice cannot be served individually, the order is herby issued ex-parte.
