Whereas, information has been received from Addl. Director General of Police Intelligence Branch, West Bengal vide Org No. 8279(19)/DS(S)//F.No. -860(A)-2003 dated 09/10/2024 regarding the proposed arrival and departure of Hon'ble Defence Minister Shri Rajnath Singh on 11/10/2024 & 12/10/2024 from Bagdogra Airport (Air Force Station) under Bagdogra PS, Siliguri Police Commissionerate.

And

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Notification No. 1548/1(8)-P.S. Cell/HR/O/3P-42/14 dated 16/08/2024 of Senior Deputy Secretary to the Govt. of West Bengal.

And

Now therefore, in exercise of the power conferred by Sub-section (1)(3) of Sec. 163 of the Bharatiya Nagarik Suraksha Sanhita of 2023, **I, C. Sudhakar, IPS** Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area

of Siliguri, do hereby order that "No drone shall be flown within a distance of 05 (five) km from the periphery of Church More (SPC Border) to Bagdogra Airport (Air

Force Station) under Bagdogra PS Siliguri Police Commissionerate.".

Exigency of the situation does not allow me to serve the notice to the aggrieved parties, if any, and order is passed ex-parte u/s 163(2) of BNSS of 2023.

This order will take into immediate effect and will remain in force till the completion of the proposed visit.

Whereas, information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquillity and breach of the peace in the area mentioned in the schedule below of the NJP PS, under the Siliguri Police Commissionerate.

Whereas, I, Commissioner of Police, Siliguri being the Executive Magistrate for the Metropolitan area of Siliguri, have been specially empowered by the State Government vide Notification No. 1548-P.S. Cell/HR/O/3P-42/2014 dtd 16/08/2024 of Senior Deputy Secretary to the Govt. of West Bengal.

And

Whereas, in my opinion, there is sufficient ground for proceeding under the said section for immediate prevention of disturbances of public tranquillity and breach of peace within the area-inquestion of the Siliguri Police Commissionerate.

And

Now therefore, in exercise of the power conferred by Sub-section (1)(3) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit for the period 60 (sixty) days

w.e.f **25**th **October 2024 to 23**rd **December 2024** until further order, any assembly of 05 (five) or more person in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquillity and breach of the peace within the said area of NJP PS, Siliguri Police Commissionerate.

The area within the jurisdiction of NJP PS bounded:

- 1) On the North By: Power Grid Guest House.
- 2) On the East by : Residential Apartment styled as "Basundhara Abasan".
- 3) On the West by: NH-34.
- 4) On the South by: Feeder Road at Kamrangaguri.

C.O. NO. 3699 Date: 03. 10.2024

Whereas, information has been received from reliable sources that smuggling and infiltration within 8 kms of Indo-Bangladesh International Border under Siliguri Police Commissionerate are causing / likely to cause grave danger to human life, property and public and a speedy remedy is necessary.

Now therefore, in exercise of the power conferred by Sub-section (1)(2) of Sec. 163 of Bharatiya Nagarik Suraksha Sanhita, 2023 (2 of 2023) I, C. Sudhakar, IPS, Commissioner of Police, Siliguri Police Commissionerate and Executive Magistrate for the Metropolitan area of Siliguri, do hereby prohibit movement of food grains and foodstuff i.e. rice, paddy, sugar, salt, wheat, pulses and other essential commodities and movement of trucks carrying cattle, livestock etc from 7-00 P.M each day to 6-00 AM next morning daily within 8 kms of Indo-Bangladesh International Border areas under Siliguri Police Commissionerate. In addition to this, grazing of cattle at night within 300 (Three hundred) meters of Indo-Bangladesh International Border is also prohibited from 7-00 PM each day to 6-00 AM next morning.

This order will take immediate effect and will remain in force from 1st October 2024 to 29th November 2024.

In c/w Calcutta high Court, In the Circuit Bench at Jalpaiguri CRM.(DB)415 of 2024,SI (UB) Md.Sanaullah of NJP PS,SPC (I.O)did not seized forged documents and produced before Ld. Court. In response to a further query he states that he did not proceed with the investigation in view of the direction received from the officer-incharge of the Police Station 20 to 25 days ago not to proceed. Being the officer-in- charge SI(UB) Nirmal Das failed to supervise and discharge his duties properly.

Heard him. Explanation not found to be satisfactory. SI (UB)Nirmal Kr. Das OC NJP PS,SPC is "Censured".

Coochbehar on deputation at Siliguri PC was detailed to perform L/O duty at Siliguri PS,SPC but found unauthorized absent w.e.f 23.09.2024 vide Siliguri PS Org No-5056/24 dt-23.09.2024 vide Siliguri PS Org No-5056/24.He joined his duty on 27.09.2024 a.m after being unauthorized absent for 04 days w.e.f 23.09.2024 am to 26.09.2024 pm.

Heard him. His excuse is not believable. He is "Censured" and his 04 days absent period w.e.f 23.09.2024 am to 26.09.2024 pm is treated as EOL.

Paul submitted Charge Sheet vide Siliguri PS Charge Sheet No-131/23 dtd-28.03.2023 506/379/420/465/486/471 IPC r/w sec-24 Maintenance and welfare of Parents and senior Citizen Act, which was received by court on 01.04.2023 but the said C/S has been produced before Ld. ACJM, Siliguri Court on 24.07.2024.As per statement of SI (UB) Rabin Thapa,GRO,Siliguri Court, SPC the Charge Sheet could not tag with record copy in due time to scarcity of space and infrastructure as well as shortage of manpower. However the Charge Sheet could not be produced in due time due the mistake and negligence of const-252 Jagai Ch. Das who used to tag Charge -Sheet with received file that such important documents like Charge Sheet misplaced.

Heard him. It was his responsibility to tag Charge sheet with case docket. He submitted that it was done by trainee officers. But it is imperative that he should have checked the works of those trainee officers.

Const-252 Jagai Ch. Das is "Censured".

FINAL ORDER PASSED BY SHRI TANMOY SARKAR, IPS, DY.
COMMISSIONER OF POLICE (HQ) SILIGURI POLICE
COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO15/2024 DATED-25.07.2024 DRAWN UP AGAINST ASI (UB) 54
KANAK DAS OF SILIGURI POLICE COMMISSIONERATE

The charge as drawn up against ASI (UB) 54 Kanak Das is summarized below:-

On 03.04.2024 at 22.45 hrs ASI (UB) 258 Dhirendra Nath Mandal of Matigara PS, SPC returned to Matigara PS and brought under arrest four (04) accused persons namely i) Ramji Roy @ Mody (22) S/O- Lt-. Narayan Roy of Sukti Godown, PO+ PS- Matigara, Dist- Darjeeling, ii) Md Sagir (21) S/O- Md Sharifot of Biswas Colony, PO+ PS- Matigara, Dist-Darjeeling, iii) Sanjit Roy (21) S/O- Subodh Roy of 6th Mile, Gowaljote, PO- Nimai, PS- Matigara, Dist-Darjeeling and iv) Jayanta Singh (18) S/O- Ishant Singha of 6th Mile, Gowalijote, PO-Nimai, PS-Matigara, Dist-Darjeeling while they were committing public nuisance at Matigara Bazar under Matigara PS and kept them at PS Lock-up after observing all hazar rules vide Matigara PS G.D.E No- 176 dated-03.04.2024. ASI (UB) 258 Dhirendra Nath Mandal submitted proscecution against all four accused persons which refers to Matigara P.S Non FIR P.R No.- 335, 336, 337, 338 dated- 04/04/2024 u/s-290 IPC. Two accused persons namely i) Sanjit Roy (21) S/O- Subodh Roy of 6th Mile, Gowaljote, PO- Nimai, PS- Matigara, Dist-Darjeeling and ii) Jayanta Singh (18) S/O- Ishant Singha of 6th Mile, Gowalijote, PO-Nimai, PS-Matigara were enlarged on bail vide Matigara PS GDE No-177 dated-03.04.2024.

On 04.04.2024 he [ASI (UB) 54 Kanak Das] of Matigara PS, SPC along with Const-1051 Dipankar Roy Basunia and VP- 04 Dipak Barman was entrusted to take the remaining two accused persons namely- i) Ramji Roy @ Mody (22) S/O- Lt-. Narayan Roy of Sukti Godown, PO+ PS-Matigara, Dist- Darjeeling and ii) Md Sagir (21) S/O- Md Sharifot of Biswas Colony, PO+ PS- Matigara, Dist-Darjeeling for conducting their Medical Examination at Matigara B.P.H.C vide Matigara PS GDE No- 204 dated-04.04.2024 by Govt. Vehicle No- WB-77-4756. While taking the accused persons from the Govt. Vehicle to the Hospital premises both accused tried to escape. After a hot chase they apprehend one accused person namely- Ramji Roy @ Mody (22) S/O- Lt-. Narayan Roy of Sukti Godown, PO+ PS- Matigara, Dist- Darjeeling while the other accused managed to flee away. On 05.04.2024 search was conducted and the accused person namely - Md Sagir (21) S/O- Md Sharifot of Biswas Colony, PO+ PS- Matigara, Dist-Darjeeling was apprehended and forwarded before Ld. ACJM, Siliguri Court. He failed to discharge the duty assigned to you faithfully. His such careless attitude and negligent act showed an aberration from the ethics of the disciplined department and tarnished the image of Police Department in the eye of common people.

The charged ASI (UB) 54 Kanak Das received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 30.07.2024 . He submitted his written explanation on 05.08.2024, wherein he has pleaded guilty to the charge drawn against him.

In view of all that has been stated above, it is evident that the Charged Officer is guilty of the charges framed against him in the departmental proceeding. He himself has pleaded guilty, which has confirmed that his admission of guilt is at his freewill after being fully aware of the charges and implication of his admission. Last but not the least, the documents having exhibited and confirmed by a prosecution witnesses concerned make it beyond all reasonable doubt as to the guilt of the Charged Officer of all the charges. Considering the charges and his past service records, he should be meted out with punish ment.

On 07.10.2024 the Charged ASI (UB) 54 Kanak Das was heard by me personally, wherein he pleaded guilty.

After applying my mind judiciously, I pass the Final Order as:-

"The pay of the Charged ASI (UB) 54 Kanak Das is immediately reduced by one increment for one year without cumulative effect."

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
