FINAL ORDER PASSED BY TANMOY SARKAR COMMISSIONER OF POLICE (HQ) SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO-06/2023 DATED-07.02.2023 DRAWN UP AGAINST ASI (AB) 1057 UTPAL CHAKRABORTY OF SILIGURI POLICE COMMISSIONERATE

The charge as drawn up ASI (AB) 1057 Utpal Chakraborty is summarized below:-

During an course of interrogation at the Office of Detective Department, SPC in c/w Pradhanagar PS Case No- 957/2022 dt-18.11.2022 u/s-406/417/120/506 IPC with one accused person named Raj Pandey S/O Satyendra Prasad Pandey, resident of Uma Charan Bose Lane, Kharmanchak, Dist- Bhagalpur Bihar, presently residing in a flat at Mountain Residency at Dagapur behind Gyan Jyoti College, Siliguri who used to introduced himself as Senior Deputy

Collector (BAS) posted at Patna, Bihar. During enquiry he could not show any official documentation/Identity revealing his post where I.O SI (UB) Rabindranath Sarkar of Pradhannagar PS, SI (UB) Abhishek Theengh and C/1413 Sujit Sarkar were present. Later he agreed to show his official identity proof and arms license to I.O which he kept in his flat at Mountain Residency at Dagapur behind Gyan Jyoti College, Siliguri. When they reached at the flat and were waiting for the accused to show his documents, all of a sudden he came with an automatic pistol and threatened the police force. When the police force tried to convince the accused, two shots were fired by the accused from which I.O SI (UB) Rabindranath Sarkar was grievously injured. One 7.6 mm Pistol (0.32 inch) RP-209337, GSF-IN-2015 loaded with two rounds of live cartridge in the Magazine fitted in the pistol as well as two pieces of fired bullet heads were seized from the possession of accused person. On enquiry it was found that the Gun Licence was issued by Siliguri Police Commissionerate to the arrested accused Raj Pandey. Being the Officer-In-Charge of Arms Licence, SPC he (ASI (AB) 1057 Utpal Chakraborty) did not check/scrutinised the documents submitted by the accused during the time of applying for issuance of Arms Licence and also failed to collect the rent receipt certificate from the accused Raj Pandey. This is a gross violation of work and ethics.

The charged ASI (AB) 1057 Utpal Chakraborty received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 09.02.2023. In his written reply dated 14.02.2023, he did not plead guilty to the charges drawn up against her and preferred an open enquiry. The Proceedings File No. 06/2023 dated 07.02.2023 was endorsed to Shri Narendra Kalikotay the then Assistant Commissioner of Police (SB), SPC as E.O. for the enquiry. On his transfer the file was re-endorsed to Shri Puran Rai the then Assistant Commissioner of Police (West-II), SPC. On his transfer the file was again re-endorsed to Shri Tridib Sarkar, Assistant Commissioner of Police (West-I), SPC and submission of findings at an early date. On Completion of enquiry, the E.O Shri Tridib Sarkar, Assistant Commissioner of Police (West-I), SPC submitted his findings on 01.03.2025.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as 11 P.Ws, concerned 18 documents were referred to as exhibits. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to defend herself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 01.03.2025 with the opinion that charge as levelled against Charged Officer ASI (AB) 1057 Utpal Chakraborty has well been established probabilities.

On 05.03.2025 the Charged ASI (AB) 1057 Utpal Chakraborty was heard by me personally, wherein he did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as:-

"The pay of the Charged ASI (AB) 1057 Utpal Chakraborty is reduced by two increment for one year w.e.f -01.03.2025 to 28.02.2026 without cumulative effect."

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order

**FINAL ORDER PASSED BY TANMOY SARKAR COMMISSIONER OF POLICE (HQ) SILIGURI POLICE COMMISSIONERATE IN C/W THIS UNIT PROCEEDING NO-20/2023 DATED-14.08.2023 DRAWN UP AGAINST ASI (UB) 433 UTTAM KR DHAR OF SILIGURI POLICE COMMISSIONERATE**

The charge as drawn up ASI (UB) 433 Uttam Kr Dhar is summarized below:-

While being posted at Khalpara TOP under Siliguri Police Commissionerate he [ASI (UB) 433 Uttam Kumar Dhar] along with C/717 Hirak Roy and CV 980 Ranjan Ojha were on mobile van duty on 04.07.2023 at Khalpara TOP area he arrested one person namely Dipanjan Roy, S/O- Prabhat Roy of Ward no 13, Haranath Pally, PS-Sonamukhi, Dist- Bankura. On the same day accused person got bail. However, the reason of the arrest could not be justified. Further, it was found that SI (UB) Mrinmoy Ghosh OC Khalpara TOP, SPC have got no knowledge about the arrest of the accused Dipanjan Roy on 04.07.2023 night and no permission was sought by him for releasing him on bail.

His such moral turpitude, indiscipline conduct and dereliction of duty is detrimental to this disciplined Police department and tantamount to infringement of Rule Nos. 03 & 04 of West Bengal Government Servants' conduct Rules, 1959.

The charged ASI (UB) 433 Uttam Kr Dhar received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 16.08.2023. While being posted at Pradhanagar PS, SPC on 11.11.2022 at 13.10 hrs when she [LSI (UB) Sunanda Sonar] was performing GDE duty, SI (UB) Sibdhan Karmakar returned to PS along with one accused Arpan Sarkar in c/w Pradhannagar PS Case No-748/22 Dtd-21/09/22 U/S-380 IPC. After the thorough search by arresting officer, she put the accused inside the P.S lockup in presence of LC-1269 Pramila Chhetri. On the same day at around 16.55 hrs the accused attempted to commit suicide by hanging himself at male P.S lockup by a piece of bed sheet. SI (UB) Atanu Majumder of Pradhanagar PS, SPC noticed the incident and the accused was rescued and shifted to the Medica North Bengal Clinic Nursing home, Pradhanagar for his treatment. She [LSI (UB) Sunanda Sonar] being the General Diary Officer on 11.11.2022 failed to keep constant vigilance

upon the activities of accused persons inside the PS Hazat. It was a gross negligence and casual approach on her part.

The charged LSI (UB) Sunanda Sonar received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 11.02.2023. In her written reply dated 16.02.2023, she did not plead guilty to the charges drawn up against her and preferred an open enquiry. The Proceedings File No. 09/2023 dated 10.02.2023 was endorsed to Shri Gyalsen Lepcha. The then Assistant Commissioner of Police (Traffic HQ), SPC as E.O. for the enquiry. Due to his transfer the file was re-endorsed to Shri Tridib Sarkar, Assistant Commissioner of Police (West-I), SPC and submission of findings at an early date. On Completion of enquiry, the E.O Shri Tridib Sarkar, Assistant Commissioner of Police (West-I), SPC submitted his findings on 01.03.2025.

I have carefully gone through the deposition of prosecution witnesses, Defence witness, contents of exhibits, written statement of defence and all other related papers pertaining to this departmental enquiry. During course of enquiry, the Enquiry Officer had examined as many as 09 P.Ws, concerned 14 documents were referred to as exhibits and 03 DWs was produced by Charged Officer. It is found that the enquiry was held as per rules and regulations and reasonable opportunity was also given to the Charged Officer to defend herself for the sake of natural justice. After weighing all documentary evidence, records, deposition of P.W.s the E.O. submitted his findings on 01.03.2025 with the opinion that Charge levelled against the LSI (UB) Sunanda Sonar has well been established probabilities.

On 06.03.2025 the Charged LSI (UB) Sunanda Sonar was heard by me personally, wherein she did not plead guilty.

After applying my mind judiciously, I agree with the findings of the E.O. and pass the Final Order as:-

"The pay of the Charged LSI (UB) Sunanda Sonar is reduced by one increment for one year w.e.f 01.03.2025 to 28.02.2026 without cumulative effect."

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order

The charge as drawn up against ASI (UB) 124 Taraknath Adhikary is summarized below:

He [ASI (UB) 124 Taraknath Adhikary] of Siliguri Police Commissionerate was granted and proceeded to avail 05 days E.L on M.C w.e.f-14.05.2024 a.m to 18.05.2024 p.m vide Co No-2167 Dated-13.06.2024. He did not join his duty on time and thus found overstaying from E.L on M C w.e.f 19.05.2024. In this context several warning notices were issued to him at his residential address through I/C Balurghat PS, D/Dinajpur vide this unit Org No- 917/RO, SPC Dated-01.07.2024, Org No- 975/RO, SPC Dated-08.07.2024, Org No-1412/RO, SPC Dated-05.09.2024 & Org No- 1651/RO, SPC Dated-08.10.2024. Later on, he reported his arrival at Reserve Office, Siliguri Police Commissionerate on 30.01.2025 p.m after overstaying from E.L on M.C for 257 days w.e.f 19.05.2024 a.m. to 30.01.2025 p.m. His unauthorized absence shows his lackadaisical attitude, gross negligence and dereliction of duty towards Govt. duty which is against of ethics of this disciplined Police department.

The charged ASI (UB) 124 Taraknath Adhikary received the copy of Charge & Statement of Allegation along with all relevant documents under his signature on 27.02.2025. He submitted his written explanation on 27.02.2025, wherein he has pleaded guilty to the charge drawn up against him.

In view of all that has been stated above, it is evident that the Charged Officer is guilty of the charges framed against him in the departmental proceeding. He himself has pleaded guilty, which has confirmed that his admission of guilt is at his freewill after being fully aware of the charges and implication of his admission. Last but not the least, the documents having exhibited and confirmed by a prosecution witnesses concerned make it beyond all reasonable doubt as to the guilt of the Charged Const of all the charges. Considering the charges and his past service records, he should be meted out with punishment.

On 06.03.2025 the Charged ASI (UB) 124 Taraknath Adhikary was heard by me personally, wherein he pleaded guilty.

After applying my mind judiciously, I pass the Final Order as:-

"The pay of the Charged ASI (UB) 124 Taraknath Adhikary is immediately reduced by one increment for one year w.e.f-01.06.2024 to 31.05.2025 without cumulative effect. The increment of the Charged officer ASI (UB) 124 Taraknath Adhikary should be recovered in next three (03) months.

The unauthorized absent period of ASI (UB) 124 Taraknath Adhikary w.e.f 19.05.2024 a.m. to 30.01.2025 p.m total 257 days out of which absent period w.e.f-19.05.2024 a.m to 25.09.2024 pm in total **130 days is treated as E.L** & absent period w.e.f 26.09.2024 a.m to 28.01.2025 p.m in total **125 days is treated as Commuted Leave &** absent period w.e.f 29.01.2025 a.m to 30.01.2025 p.m in total **02 days is treated as E.O.L.** . Held over pay, if any, be released after necessary adjustment."

As per Rule 883 of PRB Vol –I the Charged Officer is at liberty to appeal against this order before the Appellate Authority within 37 (thirty seven) days from the receipt of the copy of the Final Order.
